Polk County I, Gatty Bobo of the State and County aforesaid being advanced in years but of
sound disposing mind & memory do by these presents make out and seal my
and Domicile and to establish this my last will and testament as follows

I give and bequeath to my beloved daughter Caroline who this day resides with me
the Household Estate wherein I now reside consisting of lot of land one hundred acres
and Eighty 1280 in the third District and fourth Section & originally belonging to her late now
Polk County containing forty two acres more or less also I bequeath to the said Caroline
Bobo my daughter as aforesaid my entire out door household property as also my house
hold & Kitchen furniture as I may be in the peaceful & lawfull possession of at the time
of my death so much of the aforesaid household property as house hold & Kitchen furniture
as my beloved daughter Caroline may elect to be sold for the purpose of paying my
just debts as also funeral expenses. The above bequest is hereby directed to be
to the exclusion of all my other children they having received in former gifts a
sufficiency to make them equal. By virtue of these presents I authorize the aforesaid
legatee namely Caroline Bobo at my death to take into her possession all the
aforementioned Estate to be hers in fee simple after paying all my just debts and
general expenses as herein provided for. In testimony of the said Gatty Bobo have
Signed the within instrument abiding the same to be my last will and testament hereby
revoking all other or former wills by me made in the presence of A. H. Jenkins
A. Johnson & W. Herriige who on their part do testify that they were called upon by the
aforesaid Gatty Bobo as witnesses the above will was read and acknowledged by
the said Gatty Bobo to be her will and she signed the same in our presence we do solemnly
believe that the said Gatty Bobo was of sound mind and memory Gatty Bobo Testator.
