has blessed me with do Ordain and Publish this my last will and testament hereby
revoking all other wills by me at any time heretofore Made

Item 1st I desire and direct that my body be Buried in a decent and Christian like manner
Suitable to my Constitution in life

Item 2nd I will and bequeath all my property of all kinds to my wife Nancy L. Offert and my
children born and to be born them and share alike

Item 3rd I desire and direct that the property so bequeathed to my said wife shall never be
subject to the debts liabilities or contracts of any future husband she may have

Item 4th I constitute and appoint M. S. Judkins Guardian of said children

Item 5th I desire and direct that all my property be kept together for the joint use and benefit
of my said wife and children provided that said property may be divided upon an
agreement made by said guardian and my said wife

Item 6th I constitute and appoint M. S. Judkins Executor and Nancy L. Offert Executrix
of this my last will and testament

Item 7th I direct and authorize my said Executor and Executrix to continue in business
to engage in new business to sell and invest in other property or to put
money at interest as they may deem best for said testator's trusts
