

## **Pulaski County Will Book A (1816-18)**

**ADAMS. Robert H. Adams. 6/3/1846. We, Jonathan E. Clements and Nancy Wood, were present last Friday, 29 May 1846, at the residence of Robert H. Adams and before his death he called on us to take notice and remember what he was about to say. He wished us to understand that his wife Rebecca should have all his property without interference of any person whatsoever so as to raise his family and as each of the boys comes twenty-one she is to give them a horse, bridle and saddle.**

**ANDERSON. Jordan. 12/6/1822: 3/3/1823. Wife, Polly, Lot 284 whereon I live, etc. Children: John, Lawrence, Robert, Betsy, Henry, Polly Ann and Thomas Jordan Anderson. Son-in-law: Eli Horne and his wife, Sally, to educate the children. Wit: Gideon Kellam, Simon Bardin, Green H. Chaines.**

**ARD. Neil Ard. 4/21/1817: 5/5/1817. Wife, Easter all estate and when my youngest child becomes 21 to be equally divided amongst all my children. Exrs: Wife, Easter Ard, Martha Singletary, Hugh Carr. Wit: William Kelly, Elizabeth Lavin, Hannah Moonly.**

**ARTHUR. William Arthur. 3/10/1840: 10/12/1840. Friend, Charles Walker, exr, all estate. Wit: Robert W. Halstead, James H. Dunham.**

**ATKINS. Ica Atkins. 1/17/1833: 3/4/1833. Wife, Mary, negroes, etc. Son: L. B. Atkins. At death of my wife the estate is to be divided equally between: L. B. Atkins, Ica Atkins Jr., Richard Atkins, Sarah Phelps, Jane Mitchell, Mary Howell, Littis G. Matthews and James I. Atkins. Exr: Son, L. B. Atkins. Wit: S. N. Phelps, Fredrick Ballard, S. Bishop.**

**BARBER. Fredrick Barber. 8/22/1831: 11/14/1831. Wife, Mary, all estate except to eldest son, Thomas Barber part of lot 155 and part of lot adj. it laid off to him by me being 200 acres. Sons: W. Gilberry Barber and Fredrick Barber, land lot 154 and balance of my land on that side of Burk**

**Creek. To Jonathan Barber's three children-James, William, Thomas, 50 acres of land that John Keen lives on, being the north west corner of lot 195 with the said Jonathan Barber to have use of the land so long as he remains on with the children. Grandchildren: Green McVay, Francis McVay, Stansell McVay and Allison McVay, they being the children of my daughter, Clarissa McVay, the north east corner of land lot 226, being 50 acres. My son-in-law, John W. McVay. To Gilberry and Fredrick Barber each a colt. My little daughter, Mary Caroline Barber, a negro named Mary. To my daughter, Elafair Barber, a negro named Sarah. My son, Gabriel, to be schooled. Sons: Gabriel, John Bentley, Green and James Bryant Barber. Exrs: Mathias McCormick and Hugh Lawson. Wit: P. B. Causy, P. Collins, John Keen.**

**BARKER. Bartlett Barker. 2/3/1826: 10/30/1827. Wife, Mary. Brother-in-law: John Faircloth. To Martha Mathis. My nephew Bartley in North Carolina. Wit: Haas Jones, Morgan Swain.**

**BISHOP. Simon Bishop. 2/21/1836: \_\_\_\_. Wife, Nancy, extrx but advise her to get James S. Daniel and James O. Jeekes to assist her. The stock in a boat *Wild Cat*, my claim of hogs over the river, scattering marks and brands for cattle, etc. to pay my debts. Note against Tomas H. King. As regards the last cotton sent to Charleston on the last trip of the *Wild Cat*, reference must be made to William S. Whitfield, a particular statement of which will be found in list C. Son: James Bishop. Wit: Daniel Dunleavy.**

**BOOTHE. John M. Boothe. 9/18/1848. Nun-cupative. Andrew W. Ard, Henry L. Haas and Mildred A. Hass were present on evening of 9/14/1848 at residence of John M. Boothe before and at the time of his death. He gave his negroes, horses, colt and some notes to his father, then to brother, James. Doctor Ard attended him. He breathed his last about ten o'clock on the fifteenth day of September 1848. Signed, Andrew W. Ard, Henry L. Haas, Mildred A. Haas.**

**BOSTICK. Mary A. Bostick. 3/6/1834: 3/2/1835. Exrs: James M. Bracewell and Burwell W. Bracewell. Daughter: Caroline Virginia Pitts, negroes.**

**BRINSON. Jeremiah Brinson. 10/9/1841: 12/16/1841. Wife, Matilda, all property she had when we were married, plus slaves, and 375 acres of land in Baker Co., and the interest I have in the undivided land belonging to the estate of Alex Dennard, deceased, etc. Children: Laviza Taylor and David Kellom Brinson. To my 3 children: William Arnold Brinson, George Washington Brinson and Sarah Jane Brinson, remainder of property. Cousin: Moses Brinson, is to take charge of the three children. Exrs: Moses Brinson, Jr., Seth K. Taylor. Wit: Charles Walker, Thomas D. Walker, David Walker.**

**BROWN. Nepsy Brown. 2/17/1840: 7/4/1843. Grandson: John Brown, son of Edmund Brown, 202 1/2 acres, being the east half of lot 212 in district 21 and the east half of lot 239, negro woman, Dinah, mare, colt and seven sheep. To granddaughters: Mary Ann and Margaret Brown, daughters of Edmund Brown. Exr: Edmund M. Brown. Wit: James Hays, Alexander Williams, Margaret Brown.**

**BURCH. Edward Burch, Sr. 8/7/1832: 9/14/1832. Wife, Mary, 24 acres of land, being part of fractional lot 120 with the house whereon I live. My property to be kept together and managed by my executors as long as my wife, Mary, my kinsman, and adopted son, Edward A. Burch, Jr. and John Burch shall live, and then to be divided between the children of Edward A. Burch. To: John Burch, \$100 per year. To my kinsman and adopted son, Edward A. Burch, all the proceeds from the crop each year that my executors can spare after paying John Burch his annuity and reserving**

enough to supply the plantation and my wife. My plantation is to be managed by my trusted servant Dennis under the superintendancy of some white man but Dennis is not to be under his control. Exrs: Moses Fort, John Rawls, Nelson Clayton.

**DILLARD. Phillip Dillard. 1`1/15/1828: 5/1831. Wife, Elizabeth, one lot in 22nd district, no. 151 and 1/2 of lot 180 adj. said lot 151 adj. William Brown and Thomas Rozar and my own lands; negroes. 7 children: James, Elizar Ann, Rebecca Ann, Nicholas Phillip, Sarah Ann and Sampson Dillard, and Maria Collier. Exrs: Rubin Lamb, Meedy Lamb. Wit: Nimrod Phillips, Daniel Harrell, John Rozar.**

On account of the permanent affliction of my son, John Fleming, I direct that he receive \$200 before the general division of my estate. **GRAHAM. Green G. Graham Sr. Nuncupative LWT. Hollis Kezar, Joseph S. Graham and George W. Graham were present at the residence of Green G. Graham Sr. before and at intervals up to the time of his death. On the 10th day of the month of November 1852...he became too weak to write. Beloved wife, Priscilla A. Graham should have the plantation, etc. Land Lot 8 in Dooly Co. to go to his oldest son, John A. Graham.**

**HADDOCK. Charles Haddock. 9/4/1820: 11/13/1820. Son: William \$340 in notes on William Smith. To Dicy Edwards, wife's granddaughter. Daughters: Sarah Sutton, Mary Mills, note on Jesse Cannon and Giles Nelson and one receipt of James English for collections out of sundry persons in North Carolina. Grandson: Charles Mills. Grandson: Charles Haddock. Daughter: Martha Haddock. Daughters: Sarah Sutton and Mary Mills, my crop, etc. Son: William. Exrs: Son, William and Furney Gatlin. **HAMILTON. William Hamilton. 7/28/1846: 11/2/1846. Of advanced age. Wife, Elizabeth, land in 5th and 26th district containing 405 acres and negroes. My children: Benjamin B. Bartett, James M., William G., John J., Elizabeth Ann Harrel, wife of Lovard L. Harrel, Sarah Harrel, wife of Wright W. Jeeks, my youngest son, the plantation whereon I live, being lot 339, 202 1/2 acres. Daughter: Nancy J. Farnall. To my deceased wife's grandson, James H. Lian?, Granddaughters: Mary Antionette Ivey and Harriett Ivey; One share divided between the children of my daughter, Nancy B. Farnell. Exrs: James O. Jeeks, Nelson Clayton, Delamar Clayton.
