I therefore give my soul into the hands of Almighty God hoping & believing in the forgiveness of my sins by the merits & mediation of Jesus Christ who my faithful Commit to the Earth to be buried at the discretion of my Executor hereinafter named and all my worldly Goods & devise as follows

First I give and devise to my Daughters Mary Martha & Bashaba all that tract or parcel of Land containing one hundred two and half acres situate being & lying in the County of Wilkinson and the adjacent twenty third District & number one hundred & twenty five Acres & to hold to my Daughters Mary Martha & Bashaba their heirs & assigns for ever

Also I give to my said Daughters Mary Martha & Bashaba all my Stock consisting of Cattle Hogs &c & all my household & Kitchen furniture Beds & Bedsteads &c To have & to hold to my said Daughters Mary Martha & Bashaba their heirs & assigns. Also I give unto my Son Edward Hudson & his heirs one dollar each Also I give to my Daughters Mary Martha & Bashaba one dollar each and I give to my faithful friend Lawrence my Executor of this my last Will & Testament one hundred dollars which I have hereby

signed & sealed & declared by the Testator as of his own free will
& Testament in the presence of us who at his request have signed
in the presence of each other having subscribed our names
to this

Testator and in the presence of each other, Whereupon
