God, and as touching my Worldly Estate where with it hath pleased Al-
mighty God to bless me in this life I give and dispose of the same in the
following manner Imperpetuum. I give & bequeath unto Dringwiers
William Wright my Nephew, two Cows & Calves to him & his heirs
for ever. Item I give & bequeath unto Charity Cotton my Niece & a
minor two Cows & Calves. Also one hundred & fifty Acres of land on
the Waters of the Uche Creek Adjoining lands of Mark Robinson to
her and her heirs forever. Item I give & bequeath unto Elizabeth
Penry Wright my Niece and Saddle to her, & her heirs forever.
Item I give & bequeath unto Mary Mims my Sister the sum of
three pounds Sterg in Specie and the remainder of my Estate
I give & bequeath unto the Children of my Sister Peace Pearson
Shane & Shane alike to them & there heirs forever but notwith-
standing the foregoing bequests, it is my will & desire that should
any of the Legacies die with out any heirs that the property here-
tofore bequeathed do Immediately return to the Survivor or Survi-
vors of the Deceased, that is to say should Charity Cotton die with
out an heir, the property herein bequeathed her I shall immediat-
ly fall to and be the property of Elizabeth Penry Cotton & her
Sister Lucretia Schultzy Shane and Shane alike & I do hereby
nominate Constitute & appoint Abednego Wright Executor &
Charity Schultzy Executrix of this my last will & testament and
I hereby utterly Revoke disallow and disannull all & every other will
former still Legacies Testaments, Requests & Executions, by me in any
ways before named. Witness & Resigned. Ratifying & Confirm-
ing the same as to be my last Will & Testament in Witnes-
s where of I have here unto set my hand & Seal this twenty
