(To wit) Jack, Lucy, Daphne, Mollie, Tab, Rachel, Martha,
Nancy, Tom, Beck, Walter, John, Jacob, Charney,
Hannah, Sarah, Jack, Liz, Martha, William, Lizzy,
Johnny, Amos, Lewis, Peter, Lou, John, Julia, Mary, &
Phillis, all my plate & jewels & Carriage & Riding
Wear & Livery. (Declaring that my Executors hereafter
named do Oath to be furnish'd from my Plantation
Supplies for the use of the Family and Servants in the
same manner as usually was done during my lifetime
and in Case my said Wife should think Proper to
Remove to Charleston the same Supplies be Continued
to be transmitted for the use of the Family that Place
all which bequest to my aforesaid affectionate Wife
I think proper to Recurve, is Considered &
Intended to be instead and in Lieu of the aforesaid

James M. Campbell, late the deceased, last
for the life of him and his heirs, I give & bequeath
to my son Edward the House of Purchase which was
made when near Augusta with the land thereunto appur-
tenant bounded on the South by Merca street on the
East by Campbell street on the North by Savannah
River & on the West by Springfield to be enjoyed
& enjoyed after he arrives to the Age of Twenty one
Years. The said thing being before given to his mother
until that time. It is my wish that my Estate be
kept together until my Children should marry or
arrive at the Age of Twenty one Years and that all
the Rest & Remain of my Estate both Real & Personal
not herein before devised, be Equally Divided between
my Children share & share alike to be paid to
them and each of them when they marry or arrive at
the Age of Twenty one Years - In consequence of the
Great Confidence I have in and the great affection
I have towards my dear & much beloved wife I do hereby
constitute and Appoint her Guardian of the Person
& Property of all my dear Children and make her
together with my worthy and much Esteemed friend Philip
William Barr. Rutledge Esq. John Hume Esq. & Joseph Tate
Esq. Joint Sur. During the life of my last will & Testament in
