I give devise and bequeath to Wm Redick in trust

my Estate both real and personal, Subject to the conditions
hereafter named

I give devise and bequeath to Samuel Gardner
in trust for my daughter Rebecca during her natural life
the use of, and after her death to her issue forever
One Eighth part of all my Estate both real and personal,
Subject to the conditions hereafter named

I give devise and bequeath to David Strickland in
trust for my Grand Children Rebecca Maria, Sarah
and John Strickland (children of my deceased Son John
and their issue forever as tenants in common, One
Tenth of all my Estate both real and personal, Subject
to the conditions hereafter named

I give bequeath and devise to Jonathan M. Miller
in trust for my Grand Children, Henry, Mary, Cornelia
and Elizabeth (children of my deceased Son Cassius, and
their issue forever as tenants in common, One Tenth
of my Estate, both real and personal, the income
thereof to be paid to them as may be necessary to be
the support of said children and their mother
and the word of my deceased Son to be
subject to the conditions hereafter named

I give devise and bequeath to my Executors in
trust for my Grand daughter Mary Strickland, for
her life if she is married, and her issue
after her death to be paid by my Executors

should either of the foregoing contingencies take place
thousand, and should it so happen that neither of the

One thousand Dollars equally between the two Legacies

The Legacy to my Grand Children Rebecca Maria
and Sarah Levisa, children of my deceased Son John, I
to be paid them in Cash, as either becomes of age or is mar-
It is my desire that my negroes and Lands be divided into
five Lots, say five of Land and five of negroes, by five
disinterested men, to be appointed by my Executors and that to
be drawn for by my daughters Maria Louisa, Rebecca
Sarah and by the children of my deceased Son Casper the
said Lots to be made equal in value, and, to be
valued at Cash price

The Conditions I have Subjected Legacies heretofore made
are these, Viz each is to pay or secured to be paid to my
Executors one Sixty part of the Legacy of One thousand Dollars
given to my Executors in trust for my Grand daughter
Mary Elizabeth, and also that in the event of either of my
daughters dying without leaving Issue, then and in that case
the Legacy the use of which was given to my daughter Mary
bequeathed to her during her Natural life shall remain
to and be divided between my daughter living and
the issue of either that may be dead

Lastly I nominate, constitute and appoint my friends
Gordon, M Wilson, Matthias Stiles, Henry Stiles
and James S Gardner my Executors so that my
last will and Testament, together with all other Wills
by me made
