(Viz) It is my will to be plainly & presently
Buried and that all my Just Debts be paid as soon
as possible in the manner which will be least in-
jurious to my Estate and for & towards paying my
said Debts It is my will that my Land in Anne Arundel
County in Virginia should be Sold if Mr. Henry
Bailey is still Desirous of Purchasing it that
he may have it on payment of such Sum as it
may be Rated at by Two or three Discreet Persons
to be nominated by my Executors hereafter after
Buried but if Mr. Bailey Declines Purchasing
then I desire the same to be Sold at the Discre-
tion of my said Executors It is also my will that
my Land in Franklin County in this State be also
Sold for the same Purpose) 2^d I Give &
Bequeath unto my affectionate wife Elizabeth
Glascock her Bearing Chair & Harness one horse &
all my household & Kitchen furniture Including
Dishes and Linens & Table Linens the same to be Enjoyed
by her & her family and I Bequeath her the use & enjoyment
of one third of all my other Estate During her natural life
and in case she should marry any other Person to the person

of my Death I do Give Devise & bequeath unto
the Children of my son Thomas Glascock Esquire
and half of my Estate Real & Personal Except the
Articles given to my wife & let the same to be sold
on behalfe with my other Property to the Payment
of my Debts and the life hold Devise to my wife
Elizabeth as before mentioned to be Equally Divided
amongst the Children of my said son I have &
shall alike I do Give Devise & bequeath unto the
Children of my Daughter Blanche wife of Robert
Walter Esquire the sum arising Money of my Estate
Real & Personal with the same Exception & on
the same Condition as that given to my sons Child-
ren & to be likewise Equally Divided I have & shall
alike I do Give - I do hereby nominate my said son
Thomas Glascock & my friend Robert Walter &
Abraham Jones to be Executors of the my last will
& Testament. hereby Requesting any wife I may
have that before or after my Testimony should
I write my hand & Seal the 6th day July 1792
Signed sealed & published by said William Glascock for
his last will & Testament in the presence of us who have
also witnessed the same in his presence the names of us being
