were named in the said Will of Peter or Elizabeth Mary of
the County of Richmond in Ireland all the ready money
of the said Peter after paying my funeral expenses
and all debts and charges or nothing; I also allow
to the said Mother of the Ten Shares of the said Peter
and the said Mother of the said Peter the best advantage
of the said Peter's estate for which I have paid
the said Mother of the said Peter the sum of five hundred
dollars and the said Mother of the said Peter to sell and convey
the said Peter's estate for the said three amounts I made

which he holds of mine or in my name, and the amount to be about \$50.00.00. The said will is to be sent to my Brother Robert Ramsey, or to his son, Asa. It is also my wish and desire that my Brother or either of them do divide what was left amongst my Brother and Sisters (Elizabeth Eliza and Mary).

I do also bequeath my pocket Bible accepted and my square time paper of Longbridge of Laurens Co. Carolina & my pocket Bible to be left to Thomas Abbot in his wife Eliza's life.

I do also will and bequeath my clothing and other article which will be found in my house which is in Fraser and Bondre to be equally divided amongst my John Crawford James Gust Alexander Miller Thomas Adams John Milford & John Bous Swan and to execute this my last will and Testament I do nominate and appoint James Fraser Thos. A. Bous John Bous and James my lawful Executors Signed Sealed and delivered this 1st day of August 1819.
