one acre whereon I now live I also give and bequeath to my above
named two daughters all my stock of cattle Hogs, Goats and one black
man. also my household and kitchen furniture together with all and
every other claim or interest of mine or in any way belonging to me, Equally
to be divided between my two daughters Nancy and Elizabeth, and lastly as
to all the rest and residue of my personal Estate Goods and Chattels
of what kind and nature soever I give and bequeath to my daughter

Nancy and Elizabeth to be equally divided and to share and share alike, and Lastly I have and do hereby bequeath and Mr. Williams and Mr. Williams & Co. my Executors to this my last will and testament hereby revoking all former wills by me made. In witness whereof I have hereunto set my hand and seal this the 23rd day of September Eighteen hundred and twenty eight.
