Ann Corner all my Estate both Real (and person-
al Consisting of Lands (and Negroes Stocks Horses Fur-
niture &c To have (and to hold during her natural Life or
Widowhood for the Support of herself (and my Children
that may remain with my Said Wife (and it is my desi-
re that my Said wife be permitted to love any part
of my Estate to any of my Children that may be Settled
or living to themselves

Fourthly It is my desire (and I wish it so Constructed that
immediately after the death or intermarriage of
my Said Wife that all of my Estate be Collected

together and be equally divided between all of my children
except my Son John Connor who have already receiv
from me a full share of my Estate I also do not in
tend to give to my daughter Elizabeth Beville any part
my cattle having already given her a share of my
stock (and I wish it so understood that in the division
my Estate that none of my cattle be allotted to my said
Elizabeth Beville

(and I do hereby revoke all other wills that may have
heretofore made by me

And lastly I do hereby nominate and appoint my Love
wife Ann Connor and my Son Simon P Connor Executors
of this my last Will and Testament
