all the specie money of which I may die seized

Item 3 I give devise and bequeath to my daughter Lucy
Larney wife of Jackson Larney my household
man, & my buggy & harness & one third of all
the specie money of which I may die seized
& possessed to have & to hold to her, her heirs
and assigns forever in fee simple

Item 4 I give devise and bequeath to Jackson Larney
the four cows & calves & two Bucks (Bulls) which
I had previously bargained to sell to him - To
have and to hold to him said Jackson Larney
his heirs & assigns forever in fee simple

Item 5 I give devise and bequeath all my Beds, Bed-
ding and wearing apparel to my daughter
Lucy Larney - Mary Scott and Julia A minor
daughter in law - To be divided between them
equally share and share alike, to them their
heirs and assigns forever in fee simple

Item 6 I give devise and bequeath to my son James
Larney after paying all my just debts, and after
the residue of my property real and personal

or simply that may be left after the Legacies
before named, are taken out of my said property
to have & to hold, to him James Grimes his heirs
& assigns forever in fee simple - This bequest
to include the Mark and Brand of my Stock,
Cattle & Hogs.

Then I nominate and appoint James Grimes
the Executor of this my last Will & Testa-
ment
