Item 1 It is my will and desire that all my just debts be paid as soon after my decease as possible

Item 2 I give devise and bequeath unto my grand son Isaiah Conner one hundred acres of land in said County to commence at the west side of a tract or parcel of land containing two hundred and twenty two acres adjoining Hilory Plakas land to be bounded on the south by the middle ground road North by David J. Probstland the dividing line to run East & West so as to include one hundred acres

Item 3 I give and bequeath unto my grand daughter Mary Conner to be paid to her at the final distribution of my Estate fifty dollars

Item 4 I give bequeath and devise unto my beloved wife Ellen or M and during her natural life all the residue of my Estate Subscribed & sworn to before me this 12th day of August 1888 at the County of Lincoln State of Georgia www.gutenberg.org and at her death to be equally divided between my three children in the manner and conditions following to wit To my daughter Ann Hitch midson I give bequeath and devise the one third of the property bequeathed to my wife during her life for her sole and separate use free from the ~~debts~~ liabilities or enjoyment of her husband should she ever marry and after her death to such child or children as she may leave To my daughter Hodge wife of Hardy Hodge I give bequeath and devise the one third of the property bequeathed to my wife for her sole and separate use free from the debts liabilities or enjoyment of her present or any future husband for and during her natural life and after her death to such child or children as she may leave To my son Robert Haddon I give bequeath and devise the one third of the property bequeathed to my wife these bequests to my three children Ann Susan & Robert to take effect at the death of my wife Ellen Haddon

Item 5 I hereby constitute and appoint my wife Ellen Haddon sole executrix of this my last will and testament In witness whereof I said Stephen Haddon here affixes my last will & testament contained in this sheet of paper set my hand and seal this 12th day of August in the year of our Lord one thousand eight hundred & eighty eight
