ath to her a Negro Man by the name of Baptist.

Second - To my Daughter Mariah Lockett, I give and bequeath to her
the one equal half of the tract of Land whereon I now live.

Third - To my Daughter Mary Ann Lockett, I give and bequeath to
her the other equal half of the tract of Land whereon I now live.

Fourth - To my Son Andrew Lockett, I give and bequeath to him a Negro
Woman by the name of Mary

Fifth - It is my will and desire that all the rest and residue
of my estate not heretofore disposed of is to be equally
divided with Silvester N. Lockett, William N. Lockett
Francis J. Lockett, Thomas J. Lockett, Christopher C.
Lockett, Benjamin Lockett, Mariah Lockett, Mary Ann
Lockett, my Son in law James Farley and my Two grand
Daughters, Elizabeth M. Twinnay and Sophiash Mc Twinnay
all of them are to Share, and Share a like - Provided
nevertheless, that in case either of my grand Daughters
should die before the age of Eighteen years or marriage
then I give the Share of the age of ~~8~~ her dying
unto the survivor of them. And in case both of
my grand Daughters should happen to die before attain-
ing to the age of Eighteen years or Marriage, then it is
my will and desire that the legacies bequeathed them
in this Division of my will be equally divided amongst
my sons and Daughters

Sixth - I Conjoin the Execution of the above Will upon my son
Silvester N. Lockett as Executor of this my last will and
Testament - In Witness whereof I have hereunto set my
hand and seal this fourth day of September Eighteen hun-
-dred and Thirty seven - signed sealed and acknowledged in the
