In the name of God Amen;— I Thomas Pollard of Taliaferro County and State of Georgia being of sound mind and memory thanks be to God, Calling unto mind the mortality of the body and knowing that it is appointed for man Once to die. I do make and Ordain this my last will and testament that is to say principally and first of all I give and ~~Repeat~~ bequeath my soul to god that gave it to me, and my body resign to the earth to be buried in a christian like manner at the discretion of my Executor. As touching such worldly estate wherewith it has pleased God, to bless me in this life I dispose of the same in the following manner;

Item 1st I give to my Daughter Nancy Paxton one Cow and Calf one bed and furniture, one boy maid and thirty dollars in Cash. all of the above articles she has already received; and it is my will that she may receive One dollar & fifty Cents out of my estate to be paid by my Executor.

Item 2nd I give to my Daughter Sarah Hyde one bed and furniture one Cow and Calf, and one heifer One gray horse and fourteen dollars in Cash, all the above named articles she has already received from me, and it is my will that she may receive One dollar and fifty cents out of my Estate to be paid by my Executor.

Item 3rd I give to my son Richard Pollard one Bay horse one yoke of oxen, all the above articles my said son Richard has already received from me.

Item 4th It next is my will that out of the remainder of my property all my just debts be paid by my Executor.

Item 5th and last, It is my will and testament that the remainder of Property be disposed of by my Executor, as he may think best; so that my wife Mary Pollard have a comfortable a support out of the same as it will allow during her natural life, and at her death be equally divided among my children here named. Lucy Pollard, Ediza Pollard, Harris son Pollard, and my above named son Richard Pollard his afore said part being Counted in; I now leave as my Executor John S. Murphy.
