He explained his horse was tired and that was all that ailed him. Did you hear Colding say he was going to see that Johnson's debt was paid but he would let it stand until Johnson would be glad to take little or nothing? Was this the debt alluded to where it judgment was obtained against Thomas Colding and Hillary Cason of Screven County?
