said Lots of Land containing Two Hundred two
and one half Acres with all the rights members
and appurtenances to said Lots of Land in any
wise relating free from all charges and Limitation
what ever To have now proper use benefit and
 behoof for me in fee Simple with full power to
dispose of the Same by Will or otherwise as she
may deem proper I also give and bequeath
to my beloved Wife in the Same unreserved
manner the following sitcely used on and
belonging to the Farm Situate on Lots of Land
number 206 and 207 in the 7th District of
said County which is the place where I now

Love And all of my Horses Cows Hogs and Sheep
and Stock of all kinds and all of my Households
and Kitchen furniture all without Limitation
And all of my money Notes and accounts to
her own proper use and benefit now and
with full power to sell and dispose of any part
Or all of said property mentioned and described
in this item of my Will as She may think best and
at any time and at either public or private Sale

Item fourth I hereby constitute and appoint
my beloved wife Margaret Stewart Executrix
of this my Last Will and Testament
