Georgia Troup County. I Jacob Stillwell of the State and County aforesaid. Do make, ordain and declare this to be my last Will and testament, revoking all others.

Item 1st I will that all my debts are to be punctually paid.

Item 2^d I give and bequeath to my dearly beloved wife Anne Stillwell, My land whereon I now live, containing sixty acres more or less, being part of lot A. & 75, seventy five in the 15th District, originally Cane County now Troup, One negro man named Jacob, One negro Woman named Anna, Two beds, Bed slides and furniture five Cows and Calves, One flock of Hens, two Marehens, One the other Gray, all the household and Kitchen furniture. And all my stock of Hogs, after her death and equal Distribution of said property to be made between my legal heirs.

Item 3^d I give and bequeath unto Sarah, daughter by one negro boy named Mills, which she has had in her possession.

Item 4th I give and bequeath unto my Daughter Mary Gile, the negro Girl named Susan which she has now in her Possession, also Two hundred and twenty five dollars. That her Husband Peter Gile is indebted to me.

Item 5th I give and bequeath unto my son John Stillwell, the negro man named Anderson.

Item 6th I give and bequeath unto my son Reuben Stillwell his heirs, the negro boy named Randal.

Item 7th I give and bequeath unto my son Green Stillwell, the negro boy named William.

Item 8th I will that the balance of My negroes be sold and an equal Distribution of the amount of sale be made between my legal heirs (viz) One negro man named Jesse, One negro Woman named Rachel, one negro boy named Jim, One Girl named Cynthia, One negro Girl named Eliza, One Negro Girl named Phyllis, one negro boy named William. I wish for Jesse and Rachel to Choose their Master.

Item 9th I will that all the surplus Parishable property to be sold, and like distribution to be made.

Item 10th I will that my Executors Sell the two tracts of Land drawn by me in the late Land Lottery in the Cherokee Country and after paying the expenses, a like distribution to be made.

Item Do I appoint and ordain John Stillwell, Ruben Stillwell, To be my legal
Executors, and my wife Mary Stillwell, Administratrix to this my last
Will and Testament. In testimony, I have hereunto set my
hand and Seal, this thirteenth day of July One thousand Eight hun-
dred and thirty three, and of the Independance of the united
States the fifty seventh.

being weak and infirm in body, but of sound mind and disposing memory,
do make, make and publish this my last will and testament.
Item 1st. I request that my body be decently interred.
Item 2nd. I wish my just debts ~~to~~ paid.
Item 3rd. After the payment of my just debts, I bequeath unto my Brother
in law Michael Rogers, the sum of one dollar, after the payment of
which, I bequeath to my beloved Brother, Joseph D. M. Farland all the
remainder of my Estate, both real and personal and do hereby Con-
stitute and appoint my Brother, Joseph D. M. Farland, my lawful
Executor, to carry this my last Will and testament, into full execution.
