

The Last Will and Testament
of Samuel P. Turner dec'd

I Samuel P. Turner, In the name of God
amen! being old and infirm in body but
of sound and disposing mind have thought
proper to make this my last will and testa-
ment, and do by these presents make ordain
and constitute this my last will & Testament
and do appoint and ordain my Son-in-
law Jonathan Taylor and my Son Tha-
drach R. Turner my lawful Executors to
see to and carry this my will into full
effect after my decease, and in the first
place I give and bequeath my body to
the dust from whence it came and my soul
to God who gave it - and in the second
place I give and bequeath unto my beloved
wife Sarah Turner my house & possession
of land whereon I now live, to wit one hun-
dred and thirty five acres on the North
Side of lot Number one hundred and
forty one in the fourteenth district of
originally Carroll now Troup County and
six negroes to wit Jerry a man & Nancy a
woman and her infant child
Caroline and her child Harriet, and Irwin
a boy, and two horses to be chosen by herself
out of any that may belong to my Estate after
my death, and a yoke of oxen and cart,
two cows & calves and twenty five head of
hogs to be selected by herself, Also two beds
and bedsteads and the clothing & furniture
necessary for said beds and such amount
of farming tools as may be necessary for
carrying on her farm, and all the cooking
utensils that may belong to my Estate,
all the chests, trunks, sitting chairs & side

board, cupboard, and water, dessert to 'humans'
to hold and enjoy during their natural life but
none of the above named property to be sold or
disposed nor any agent of theirs to sell or
convey or in any manner dispose of, but at full
liberty to work and use them for her support and
comfort, while she lives and at her death the
whole of the before mentioned property to be
equally divided between my children - and
thirdly I give my daughter Mary T. Taylor
one negro girl named Corrina, worth two
hundred and fifty dollars -

Fourthly - I give my daughter Martha Ann
Green one negro girl named Eliza worth
two hundred and fifty dollars -

Fifthly - I give my daughter Corrina
A. Ray one negro girl named Abigail
worth two hundred dollars -

Sixthly - I give to my daughter Jane C
Taylor one negro girl named Grace worth
one hundred and fifty dollars

Seventhly - I give unto my son Henry D
Turner fifty acres of land in the South East
corner of Lot Number Eleven in the fifthteenth
district of originally Carroll now Troup County
worth one hundred and fifty dollars and

Eighthly - I give to my son Horton S.
Turner fifty acres of land in the North
West corner of the above named lot worth
one hundred and fifty dollars and

Ninthly - I give to my son Samuel T. Turner
fifty acres of land lying in the South West
corner of the before mentioned lot worth one
hundred and fifty dollars and

Tenthly - I give to my son John J. Turner
fifty acres of land lying in the North East
corner of said lot worth one hundred and
fifty dollars - the above described lot of land

to be run off in four equal Squares, and I
gave to my daughter Elizabeth R. Taylor
one negro girl named Samantha worth one
hundred and fifty dollars, And I gave
to my son Shadrach R. Turner one negro
girl named Adaline worth one hundred
and seventy five dollars. And the bal-
-lance of my negroes and other property that
may belong to my Estate at my death
after paying my just debts to be equally divi-
-ded between all my Children in proportion
with what has been enumerated in this will
this 31st day of July 1845
