desiring to dispose of my Substantive rights and interests in real
and personal Estate this my last will and testament

- 1st I resign my body to the Grave and my Soul to good Virgin
- 2nd I desire that my just and lawful debts be paid
- 3rd Whereas by his last will and testament of my late husband
Sam Manning deceased One Seventh part a child's part of his
Property both Real and personal was bequeathed to me forever in
fee Simple and whereas it is my wish and request that my Mother
Thimote Miller do reside with my Children and assist them in
the course of the family until they severally become of lawful age
Or marry my will is that she have as a compensation for such
attention and services three fourths of said Seventh part of the said Estate
Both real and personal bequeathed me in my late husband's will
I therefore do will for her own sole use and benefit and behoof for
ever in fee Simple to take from and immediately after my deceased
husband the living with Children until they all become of age
If not she is to have Sixty dollars a year for the time she do remain
with them
- 4th And whereas by the said last will and testament of my said
Late husband deceased the right to nominate an Executor at
my deceased to complete the said execution of his aforesaid
will and testament was vested in and obligated to me I do
in presence of such power appoint and nominate Daniel
Walker of the station my Executor to carry, serve, will and
testament into complete and full effect with all and singular
the same and like powers by the said will vested in me
I do here by appoint and constitute the said Daniel
Walker my Executor to this my last will and testament to
execute my will withing and obiding here in before expressed
It is my request that the Court in whom that power is vested will
Select and grant the Guardianship of my said Children
To the said Daniel Walker during their minority

Upson County 3 and weak in body but of sound mind and memory also knowing
the uncertainty of life and the certainty of death do make and declare
this to be my last will and Testament in the following words to wit
I give my soul to him who giveth and my body to be buried in a plain
Orient and Christian form in worldly Estate I will to be disposed of in the
following manner first I will and give to my grand son William Coulter
Confer the lot of land whereon I now live it being lot number two
Hundred and twenty two in the tenth (10th) district originally Monroe now Upson
County together with all the plantation tools also give my grand son
William Coulter Confer one white ^{cow} cow with black sides with her yearling calf
and a black cow and her yearling, and also a dam black steer also eight
head of hogs (I will again to my grand son James Madison Confer
a black cow and her sucking calf also my bay mare, thimbley, I will and
bequeath to my daughter Eliza Coulter my father's and mother's also one
black cow and her yearling calf that she now has. I further will that the cow
and foal that I now have if it should please almighty God to take me at this time
or before it is much use of shoes go to support my poor family
