

## Copies of Will

Georgia

Walker County } In the Name of God - Amen.

I Alexander Coultin, of the State and County aforesaid, being weak in body, but of sound and disposing mind and memory, do make this my last will and testament hereby revoking all others heretofore made by me

Item 1<sup>st</sup> I give and bequeath unto the children of my son Alexander W. Coultin, and the children that may yet be born to him in lawful wedlock the following property, to-wit: The South part of Lot of Land No. one hundred and one and one hundred and two in the seventh district and fourth section, to be divided as follows, commencing at the mouth of the Spring branch in Lot No 101 and running with the branch nearly a west course through said lot, and up through lot No 102 up the hollow about eighty poles after crossing the big river, and then in a westerly direction to the back line, and I hereby appoint my son William W. Coultin and my son Thomas W. Coultin, Guardians to the children of my son Alexander W. Coultin, to manage and control said land for them and to their use

Item 2<sup>nd</sup> I give and bequeath to my son-in-law A. H. Colwell and my daughter Deliah Coultin, his wife, that they now have, and that may yet be born to them and also to the R. A. Hasting and Margaret Hasting, the children of my daughter Deliah Colwell by a former marriage, the following property, to-wit: Lot of Land Number one hundred and thirty eight, in the seventh district and fourth section, and the North half of lot of Land Number

one hundred and fifty one, in the seventh district and fourth section, and I hereby appoint my son Thomas R. A. Haselrig, Guardian for the last mentioned him or legate the children of my daughter Biliak Caldwell, and it is my will that my said son in law and daughter A. H. Caldwell and Biliak Caldwell, have the use of said property, bequeathed to their children, together with all the proceeds, & income during their lives

Item 3<sup>rd</sup> I give and bequeath to the children of my son James G. Coultin, Lot of land, Number one hundred and fifty six in the twelfth district and first section, and I desire that all the children my son James G. Coultin now has, and all that may hereafter be born to him in law full wedlock share equally in said lot it being the lot my son J. G. Coultin now lives on, and it is my will that my son James G. Coultin shall have the control, rents and profits of said lot of land during his life, and should my son J. G. Coultin die leaving a widow, then it is my will that she shall share the profits of said lot of land with his children she continuing to control said lot of land until her death

Item 4<sup>th</sup> I give and bequeath to my son William M. Coultin, Lot of land Number one hundred and eighty three, in the twelfth district and fourth section, it being the lot my son, W. M. Coultin now lives on.

Item 5<sup>th</sup> I give and bequeath to my son Thomas M. Coultin, all of that part of the lot of land on which my saw, and grist mill is situated, lying on the east side of the creek, the portion of the lot lying on the west side of the creek, including the mill, not disposed of

Item 6<sup>th</sup> I give and bequeath to my beloved wife Margaret Coultin, all that part of lots of land No. one hundred and one, and one hundred and two, not bequeathed to the children of my son Alexander M. Coultin, including my residence and buildings, well also all my negro, white, Dublin, Coney, Hat, Shis, and Bill, with all my black, farming tools, house hold and kitchen furniture, and all my personal property of every description, during her life, and after death I desire that it be sold and distributed among all my legatees in such manner that the shares shall be equal, and in as much as the property bequeathed to my son Thomas M. Coultin, is not equal in value to that bequeathed to my other legatees, I desire that it be made up to fifteen hundred dollars, and then to share equally with my other legatees

Item 7<sup>th</sup> I desire that all my property not disposed of in the will, be sold after the death of my wife, and the proceeds equally distributed among my children

I hereby appoint my son W. M. Coultin, and my grand son Thomas R. A. Haselrig, my exors to carry

Item first - I give bequeath and devise, to my four sisters, to-wit: Miss Orpha, Malinda, Harriet and Lydia, Center, my entire interest in lot known as the Blacksmith Shop, lot on which is a Blacksmith Shop, Wood Shop, and Paint Shop and other buildings and which are included in the and the lot adjoining said Blacksmith lot, and being known as the grange lot, my interest in the said two lots and buildings and improvements, being one half interest except the Blacksmith Shop lot, it being one tenth interest, I also give to my sisters above named my interest in the lot lying between the stable and immediately south of and adjoining the garden, also the lot lying south of said lot, bounded on the north by the Road leading to the grange yard, on the west by the Street running north and south, on the south by the property of Mrs. Brokensaw, on the east by the property of Mrs. M. R. Wardlaw, my interest in said last two named lots being a one half interest

Item second - I give bequeath and devise to my sisters named in Item first of this will, to-wit: Miss Orpha, Malinda, Harriet and Lydia, Center my entire interest if I have any in the Dwelling House and lot which includes the garden and stables attached to the same, and which they now reside

Item third - I give bequeath and devise to my said sisters above named my interest in the tools and accounts and money now on hand and the material Blacksmith Shop, Wood, Lumber and other things connected with said Blacksmith Shop, wood Shop and Paint Shop

Item fourth - I devise and direct that the tools, accounts, and money arising from the same together with the tools, Lumber and other articles mentioned in Item third, be used by my Brother W. S. Center, in carrying on and conducting the business of the Blacksmith and Wood Shop and Paint Shop and in the manufacturing of wagons and Buggy's.
