The original minutes of the Church are in Cherokee Regional Library, LaFayette, Ga. and the history of the church is in "History of Walker Co., Ga. "by Sartain which has recently been reprinted. The following is excerpts from the original minutes of the first ten years.

June 29,1839. We, a scattered few from the different churches, having been enabled by the grace of God as we hope first to give ourselves to the Lord and then to each other and believing that God has ordered that his children should be gathered together in a church capacity for the purpose of keeping house for the Lord, attending to and perpetuating the ordinances of the Gospel, to watch over each other for good, to support and labor for the spread of the Gospel in the world, do agree to be constituted into a church upon the following abstract of principles.
