and County aforesaid, considering the uncertainty of life, and that it is appointed unto all men once to die, being of sound mind and memory do make this my last Will and Testament, hereby revoking and annulling all former Wills or Testaments by me heretofore made, Item, first, - After all my just debts are paid, which I wish to be done with as little delay as possible, taking into consideration the interest of both my estate and creditors, the rest and residue of my estate both real and personal, I give, bequeath and dispose of as follows, to-wit: Item, second, - I give, bequeath and devise unto my beloved wife Susan Lott for and during her natural life, all the real estate belonging to me at the time of my death, situate, lying and being in the town of Waycross, Ware County, Georgia; also all my Household and Kitchen furniture of every kind and description; also one Horse named "Bill" with my buggy and harness; also all my plantation tools of every description, and all my hogs and cattle; also the sum of five thousand dollars to be raised in cash out of any money that I may have on hand at the time of my death or any property or notes that I may have on hand after paying my just debts and if necessary to sell real estate to raise said five thousand dollars for my said wife. I desire that my executors hereinafter named shall have full power to sell any of my real or personal property if necessary to raise said five thousand dollars for my said wife. I desire that my

by this my last Will and Testament without any order from the Court of Ordinary to enable them to raise said five thousand dollars for my said wife, and such sale to be made in such manner as may ^{be} deemed by my executors hereinafter named to be the least detrimental to my estate; I also hereby authorize my said executors at the request of my wife to sell any portion of my Waycross property and apply the proceeds of the same to the support of my said wife during her natural life, but only authorize my said executors to convey a title to my said Waycross property for and during the natural life of my said wife, and after her death to revert to my six children, to-wit: Elizabeth Lightsey, wife of Stephen J. Lightsey, and Fanny L. Simons, wife of Josiah Simons and my four sons, to-wit: John A. Lott, Warren Lott, Walter Lott and Joel Lott. And I further give to my said wife my vineyard with all its appurtenances for and during her natural life, or so long as she may manage the same to be advantageous to herself or my estate but if her management be such that said vineyard should be likely to go to ruin, then my said executors to take charge of the same, but my said wife to have the use of the net proceeds arising from said vineyard, my said wife to keep undisputed possession of my present Homestead for and during her natural life, at the death of my wife every part of my real and money or any other

to revert to my said six childrens heretofore described; or should my wife marry a second time, at her intermarriage my vineyard shall upon her marriage revert to my six childrens heretofore mentioned. Item, third, -

Item, fourth - All the residue of my ~~estate~~ estate both real and personal, money debts or in any other manner, I give bequeath and devise subject to the charge of making up the five thousand dollars bequeathed to my wife Susan Lott in the second item of this my last Will and Testament to my daughters Elizabeth Lightsey, wife of Stephen J. Lightsey and Fanny L. Simmans, wife of Josiah Simmans free from the contrall, debts or liabilities of their present or any future husband and to my sons John R. Lott, Warren Lott, and Paul Lott.

that each of my said children receive one sixth part of my entire estate not otherwise disposed of under this my last Will and Testament; and it is my wish and desire that all of my lands or real estate except such portions as may be necessary to be sold to make the sum of five thousand dollars be bequeathed to my said wife Susan Lott by the second item of ~~this~~ will should be kept together until my said son Joel Lott shall arrive at the age of twenty one years, after which time my entire estate consisting of everything to be either sold or divided in such manner as a majority of my executors and the advice of my friend W. J. McArthur may seem best for the interest of my said children and in a manner that each of my said children shall have their full ~~share~~ and equal share. It is my desire that my executors shall have full power to sell any or all of my real estate for the purpose of making distribution of the same without obtaining an order from any court whatever and that my said executors shall not have to make annual return to any court unless they find it to be to the interest of my estate provided they manage everything in an upright and equitable manner for all parties concerned and then only subject to be ruled by court for mismanagement, as the laws of Georgia may direct. I desire that my executors in making the division of my estate amongst my said children

may have been given by me during
my life time to any one of them so that
if either of my said children has ever
received more than the others that
said sums may be deducted from
their respective parts in the division.
I desire that my said executors only
charge for their commissions a reason-
able compensation for their trouble
and services and not a full commis-
sion for receiving and paying out as the
laws of Georgia directs that they
might receive.

Item, fifth. I hereby nominate and
appoint my beloved wife Susan Lott
executrix and my sons John A. Lott and
Warren Lott executors of this my last Will
and Testament, This 28th day of June 1879

The words "have" in the fifteenth line and the
word "be" in the twenty fifth line of the
second Item, and the word "hundred" in
the eleventh line of the third Item en-
terlined before signing.
