Witnesseth that for and in Consideration of the sum of One Hundred and Twenty Eight Dollars in hand paid to him the said Joseph Harvill in hand paid, the receipt whereof he doth here by Acknowledge and Every part and parcel thereof hath here by given Bargained Sold Alcind and Conveyed unto the aforesaid Dennis Lindsey his Heirs and Assigns all that Tract of Land being and being in the County of Warren and State aforesaid lying on the Waters of Ogeechee Running bounded Westward by Land Unknown Beginning at a stake running thence S. 25° 15' 49" on Bullocks Line thence N. 65° 15' 51" Chain to a pine thence N. 25° E. 49 Chain to a black oak thence S. 31° E. 22° 20' on Tabors Line to a stake thence N. 25° E. 5° 25' to a Corner in Tabors line thence S. 65° E. 32 Chain to the Beginning, Containing three Hundred Acres of Land be the same More or Less, together with all and singular the profits and appurtenances thereof whatsoever to the said Land Belonging or any ways appurtening, and every part and parcel thereunto, unto the aforesaid Dennis Lindsey his Heirs Executors Administrators or Assigns for ever to the only proper Use Benefit and Behoof of him the aforesaid Dennis Lindsey his Heirs and Assigns for ever, and the said Joseph Harvill against himself and against his Heirs Executors Administrators or any other person or persons whatsoever Lawfull Claiming shall and will Warrant and for ever Defend by these presents in Witness whereof the aforesaid Joseph Harvill hath hereunto set his hand and affixed his Seal the day and Year first above Written. of land lying in the County aforesaid mentioned
aforesaid lying on the Waters of Ogeechee River
Bounding Westwardly by land Unknown Beginning
on a Stake corner running on Bullocks land and
thence land the said tract of land having such
Marks Shape Natural & Artificially as is connected
to the plat of the said land as it fully represents
Containing three hundred Acres of land be the same
more or less together with all and singular the profits
and appurtenances thereof whatsoever to the said
land Belonging on any ways appurtenant and every
part and parcel thereunto to the said James
