 Warren County } being very much reduced by sickness and old age and
 knowing that it is appointed for all men once to die I therefore make
 and ordain this my last will and testament I bequeath my soul to
 God and my body to the earth from whence it came to be interred in a
 decent christian manner.

Item 2nd I bequeath to my daughter Susan Beaman the plantation whereon
 I now reside lying in said county on the waters of Beaver dam creek
 with all the appurtenances thereto belonging also a negro man named
 William and a negro girl named Mary known by the name old black Mary
 and a negro girl named Ann & her child George to have and to hold
 unto the said Susan Beaman forever in fee simple Item 3rd I
 bequeath to my daughter Elizabeth Matilda Wilkinson a negro woman
 Melinda and her three children to wit Louisa Antoinette & Jane and also
 a negro man Aaron to have & to hold unto the said Elizabeth Matilda for
 ever in fee simple Item 4th I will and bequeath to my daughter
 Louisa Sophia Thompson a negro man named Henry and a negro boy
 called Moses and the following girls to wit Maria & Emily the last named

girl (Emily) my said daughter Louisa Sophia has already in possession to have and hold unto the said Louisa Sophia Thompson forever in fee simple Item 5 I will and bequeath to my Great Grand daughter Martha Elizabeth Griffin a negro woman named Mary and her four youngest children namely Edward Paul Fredrick and Henry to have & to hold unto the said Martha Elizabeth Griffin for ever in fee simple Item 6th I will and bequeath to the Rev Peter Whelan for the use of the Parsonage one choice bed bedstead and bedding Item 7th I will and bequeath all my goods chattels (not herein before disposed of) notes money &c of which I may be possessed at my death to be equally distributed between the aforesaid legates to wit my daughter Susan Pkaman my daughter Elizabeth Matilda Wilkinson my daughter Louisa Sophia Thompson and my Great Grand daughter Martha Elizabeth Griffin Item 8th I will and bequeath to each of my grand sons namely Richard Stokes John Stokes and John Catin the sum of one dollar each Item 9th It is my will and desire that each of the following named persons do contribute the sum of ten dollars a year for the support of an old negro named Basil who is now old and superannuated namely Elizabeth Matilda Wilkinson Louisa Sophia Thompson and Martha Elizabeth Griffin and it is my desire that he should reside with my daughter Elizabeth Matilda Wilkinson

N B The above named negroes Mary and her four children willed to my Great Grand daughter Martha Elizabeth Griffin I have already given to her and they are now in her possession

I constitute and appoint my two Grand sons James Wilkinson and John Thompson Executors to this my last will and testament hereby revoking all former wills by me made and acknowledging this and only this to be my last will and testament In testimony whereof I Marcia Ann Crotin hereunto do set my hand and affix my seal on this the twenty second day of June in the year of Lord Eighteen hundred and fifty Signed sealed and declared to Captain McMahon in presence of

In the name of God amen.

I George M. Shuff of Warren County and State of Georgia, being of sound mind Memory, taking into mind the shortness of this life, together with the uncertainty of the same, do make and ordain this my last will & testament disposing of myself and these earthly effects with which it has pleased Almighty God to bless me; in the following manner, namely:

In the first place I give my son ^{the hands of} George M. Shuff, God who gave it and my body to be buried in a decent Christian-like manner according to the discretion of my friends.

After the payment of my just debts which I direct to be done by Executor, selling the following negroes, to wit Daniel and his wife Jane and his child Malley, and if the proceeds of the sale of the above mentioned negroes is not sufficient to pay my just debts, then my Executor will proceed to sell so much of my property as can be best spared for the settlement of my debts. I give in a bequest to my beloved Wife Unity Shuff all my estate both real and personal except one negro girl named Frances, during her natural life.

I give & bequeath to my beloved son Jonathan J. Shuff the sum of two hundred dollars.

I give & bequeath to my beloved daughter Albany Shuff and negro girl Frances and it is further my will that my property ^{all} be kept together, and after paying the expenses of keeping up the plantation, the proceeds of the place to be paid over to my beloved wife Unity Shuff to be disposed of by her
