

State of Georgia, in the name of God Amen!
 Warren County, - I, William Jones of the State and County aforesaid being in tolerable good health and of sound and disposing mind and memory do make and ordain and constitute this my last Will and Testament in manner and form following to wit. To God I commend my soul and my body to the Earth in decent burial.

First. I give to my son Henry Augustus Jones the tract of land and premises on which I now reside containing four hundred and ninety four acres more or less, one lot of land four hundred and ninety acres lying in Apppling county, ten acres of land lying in Hall county, with its improvements joining Gainesville, with the following slaves, to wit, Diller, Amy, Alexander, Billy, Jack, Sophia, Robert, Arthur, and Jeff, with all their future increase, also all my household furniture, except one Bed, Mattress, Bedstead and the usual Bed furniture, and one chest of drawers, with all my Stock, Horses, Cattle, oxen, Sheep, Goats and hogs, with all my plantation tools and carriages, all my Books (except such as my daughter Elizabeth Thomas Jones may require, also Eighty Shares of Georgia Rail Road and Banking company Stock.

Second. I give to my daughter Elizabeth Thomas Jones, one Bed, Bedstead and the usual Bed furniture, one chest of drawers, and such Works as she may require, with the following slaves to wit, Sonisa, Kit, Rachel, Andrew, Mary, George, Abram, and Jim, with all their future increase, also Eighty Shares of Georgia Rail Road and Banking ~~and~~ company Stock.

Third. I give to my daughter Mary Susanna Harper in addition to what I have already given her the debt owing to me by her husband James N. Harper amounting to about three thousand dollars.

Fourth. I give to my son Henry Augustus, my daughter Mary Susanna, and my daughter Elizabeth Thomas, fifty shares of Alabama City Stock, or the remet thereof to be equally divided between them.

Fifth. All the residue of my Estate of every kind whatever, after paying all just claims against me, I give equally to my son Henry Augustus and my daughter Elizabeth Thomas.

Sixth. It is my will that in the event of the death of my son Henry Augustus before marriage that the legacy hereby left him shall go to his two sisters equally and in the event of the death of my daughter Elizabeth Thomas before marriage that the Legacy hereby left her shall be equally divided between her brother Henry Augustus and her sister Mary Susanna's children.
