I Harriett Rice of said State and County being of advanced age and knowing that I must shortly depart from this world deem it right and proper both as respects myself and family that I should make a disposition of the property with which a kind Providence has blessed me. I therefore make this my last Will and Testament, hereby revoking and annulling all others heretofore made by me

Item first— I desire and direct that my body be buried in a decent and Christian like manner, suitable to my Circumstances and Condition, my soul I trust shall return to rest with God who gives it, as I hope for eternal Salvation through the blessed Lord and Saviour Jesus Christ.

Item second— I desire and direct that all my just debts be paid without delay by my Executor herein after named as I am unwilling my Creditors should be delayed of their rights.

Item third I give and bequeath to my daughter, Honourable Caroline Dowd wife of Nellie, I Dent my molatto girl Nanny five years of age

Item fourth I give and bequeath to my daughter Harriett Perennial Rice my negro girl Eliza two years of age I desire that my daughter named in this item may have a sum of money which shall make her negro girl Eliza value equal to the value of the molatto girl Nanny, whom I give and bequeath to my daughter Honourable Caroline Dowd

Item fifth I give and bequeath to my son Wilkinson Columbus Rice my negro woman Maria twenty three years of age

Item sixth, I desire and direct that my daughter Perennial Rice when she marries shall have a Horse worth eighty Dollars and a good Common Saddle & Bridle

Item seventh, I desire and direct that my son Wilkinson Columbus Rice when he arrives at twenty one years of age shall have a Horse worth eighty Dollars and a good Common Saddle & Bridle

Item eighth I desire and direct that my negro man Charles be sold at public outcry— I also desire and direct that the residue of my Estate consisting of five head of Horses my whole stock of Cattle and Hogs, one yoke of Oxen one Cart, Corn fodder, Cotton wheat Peas Potatoes, Plantation tools household and kitchen furniture be sold in like manner

Item ninth I desire and direct that after the liquidated my daughter Harriett Perennial Rice and to my son Wilkinson Columbus Rice have been reserved from the proceed of the sale that the remainder of said proceed be equally divided among my three children Honourable Caroline Dowd Harriett Perennial Rice and Wilkinson Columbus Rice

Item fifth - I desire and request that my bed, bed clothing  
and cloaths should remain in and belong to the family with which  
I may be living at the time of my decease

Item sixth - The rest of my property both real and personal whomever  
and whatever it may be I desire and bequeath to my son Joseph  
Warren, my daughter Phoebe M<sup>r</sup> Kinnin wife of John M<sup>r</sup> Kinnin,  
my daughter Sarah West widow of James West deceased, and  
my son Jonathan Baker to be equally divided between them share  
and share alike

Item seventh - I constitute and appoint my son Jonathan Baker  
Executor to this my last Will and Testament this 3<sup>d</sup> day of April 1852
