I Henry Wood being of sound mind of disposing

memory and of advanced age and being desirous of making a testamentary disposition of my Estate do make and constitute this as my last will and testament.

Item First I give to my sons Matthew H Wood and John A Wood in trust for my Daughter Sabitha I Blum Wife of Simon L Blum and her children the land whereon I now reside known as the home tract containing two hundred and twenty (220) acres more or less beginning at Limestone Spring adjoining land previously given to M H Wood, thence down Limestone Spring thence to the Central Rail Road, thence on the Rail Road in a North Eastern direction to the point where the Eastern boundary line of the Lewis Place tract crosses said Rail Road, thence down said boundary line to where it crosses Sand Hill Creek thence up said Sand Hill Creek to the mouth of the Branch next and nearest the head of that Creek the Rail Road near Hays Mill, thence up said Branch to the head thence North  $11\frac{1}{2}^{\circ}$  West  $14\frac{1}{2}^{\circ}$  Course thence South  $59^{\circ}$  West  $26^{\circ} 75'$  Chances thence adjoining M H Wood's land to the beginning for and during her natural life and at her death to be equally divided between them thence to be held in trust for her and her children exempt from the debts of her present or future husband said Valued at fourteen hundred dollars.

Item 2<sup>d</sup> I give to my Son Joshua Cole Wood in trust for the use and benefit of the children of my Son William M Wood one lot of land N 61 in the 1<sup>st</sup> District of Lawrence County containing two hundred two and one half (202 1/2) acres and one hundred acres on Sand Hill Creek in Washington County adjoining lands of Estate of Thomas E Hoyle J D Everett A Morrison and the heirs of one of Lewis A Holt to be held in trust until the youngest child shall come of age or marriage thence to be equally divided between them share & share alike and also the one hundred dollars advanced to my son William M Wood during his life.

Item 3<sup>d</sup> I desire that all of my estate both real and personal of every description not herein before bequeathed or given off by deed of gift to my son Matthew H, John Wesley and Joshua Cole, be given to my beloved wife Francis Wood for and during her natural life and at her death to be equally divided between my children Matthew H Wood John Wesley Wood Joshua Cole Wood Sabitha I Blum and the children of my Son William M Wood and Benjamin R Wood the portion

concerning to the children to be held in trust for them by the same trustee and in the same way as the other bequests hereinbefore mentioned.  
 Item 14 In the event of the death of my daughter Sabitha I stand before her youngest child be of age, then the postage given to her and the children to be held in trust by the trustee named in item 13 until the youngest child shall become of age.

I testify that the said Henry Wood have hereunto signed seals and published the foregoing my last Will and Testament thereby revoking all former Wills in the presence of the undersigned who subscribed their names thereto at his request in his presence and in the presence of each other this the 9<sup>th</sup> day of January 1873. I appoint Matthew H. Wood and Joshua Deale Wood Executors of this my last Will and Testament.

## Henry Will

Georgia Washington County In the name of God Amen

I Henry Will being old and weary of life of sound and disposing mind and memory do make this my last Will and Testament hereby revoking all others heretofore made by me.

Item first - It is my Will and desire that my son Henry Solomon Will move to my place as soon as he can build suitable buildings to live in and live on my place as long as I may live to take care of me in my old age and that he take control of my business and working the place try to make a support for me and my three Daughters living with me namely Adaline Sarah Ann Caroline and Carter Ann Elizabeth and so long as I may live each year after a support is made and provided for his family and mine that he receive one-half the surplus made on the place.

Item second - It is my Will and desire that all my just debts be paid.

Item third - It is my desire that my body be buried in a decent manner at New Bethel Church by the side of my daughter Angelina.

Item fourth - I Will and bequeath to my son Henry Solomon and my three Daughters Adaline Sarah Ann Caroline and Carter Ann Elizabeth, have all my property both real and personal to share equal in dividing said property, and if any one of the persons mentioned children should die without marrying and leaving lawful heirs the survivor to share their part equally.

Item fifth I do hereby appoint my friends Andrew E. Farver and Eldridge Page my Executors of this my last Will and Testament.
