Fourthly, It is my Will and desire at the intercession of my Wife that all my property be sold and an equal division be made between her and my children

5th Fifth - It is my Will and desire that at the death of my beloved wife Elizabeth Perry Yates that all my property be divided in

Sixth If my woman Jane should at any time become so disagreeable as not to suit the family it is my desire that she and her youngest child be sold and the money put at interest for the benefit, of my Children each one to draw their share as they marry or become of age.

Seventh I do hereby nominate constitute and appoint my friend William J Archer Executor of this my last Will and Testament this the twenty first day of August in the year of our Lord one thousand eight hundred and sixty one
