Robert Cummens Will.

I Robert Cummens of the State of Georgia and County of Washington being of sound mind and memory Ordain and appoint this my last Will and testament.

1st That my body be decently buried

2nd That all lawfull debts that may be against me at my death be justly paid

3rd I leave to my beloved Wife Sarah Cummens during her life, all my land Estate except such parcel as shall remain after her decease, also the six slaves following, Gilbert her, Ben Jems Lucy & her daughter Marilla, One Horse and Buggy with three good Horses, or Mules for farming purposes a sufficient amount of farming tools, Also the Household and Kitchen furniture of which she shall have entire control, allowing our Daughter Amanda to live with her while she may remain single, if she choos to do so. Also she is to have the use of the Tin Rummey gear and Blacksmith Tools, a sufficient amount of Stock of all kind, with Bacon, Corn Tobacco and Grains of all kinds, to supply her farm one year.

4th I give and bequeath to my beloved Daughter Martha and the children lawfully begotten of her body One negro girl, Malinda and her increase, said girl having been sold by Robert Wilson

5th I give and bequeath to my beloved Daughter Amanda the heirs lawfully begotten of her body two negro girls, Meriah & Cornelia and their increase. Also one Horse Marks, and one hundred Dollars, One Bed and furniture worth fbo Sixty Dollars. In the event of her death without issue, all to return to my children.

6th I give and bequeath to my beloved son John One negro man Elbert who sold by him, Also one Bed and furniture or its worth fbo Sixty Dollars

7th I give and bequeath to my beloved son David One negro man Jacob, One Bed and furniture or its worth about fbo Sixty Dollars.

8th I give and bequeath to my beloved son Thomas one negro man Isaac One Horse worth one hundred Dollars, One Bed and furniture of its worth fbo

9th It is my Will that my Grand daughter Fanny Miller, shall have at my death One good and healthy Negro girl between the age of 16 and 20 and one hundred Dollars, the same to be held in trust by my son David until she is 21 years old, provided she is lawfully married. In the event of her death without issue, all to return to my children.

10 I give and bequeath to my beloved Sons David and Thomas that portion of my land known as the Rocklawn Farm, the Saw Mill with all the appurtenances thereto belonging with the log Barn but none of the lumber that may be there at my death. Also the two hundred Acres of the Weston tract, That part next adjoining to the Mill Also that parcel purchased of R. P. Martin. Also an other lot, purchase of J. May

11 All the land and negroes I leave to my wife Sarah Cummens to be equally divided at her death, except one fourth acre annexe

the spot where my children are buried the reserve for the purpose of
a burying place

12 The remaining portion of my Servants not herein disposed of
with any amount of perishable property that may be at my death to
be equally divided among my children

13 As soon as convenient after the death of me and my wife
my Executors to procure suitable grave stones and have them placed
at our Graves

14 I hereby Constitute and appoint my beloved Sons David &
Cumming and Thomas J. Cumming Executors to this my last
Will and Testament Robert Cumming (P.S.)

ter Martha A. Wilson shall have her part at his death to belong
to her Children five hundred acres of Pine Land taken off by me
as payment for the time adjoining David Cumming's Mill
Fulgham Tobias Burgundy and others, the sum to be equally
divided between them It also add to what I have given to my
Grand Daughter Nancy Miller, five hundred Dollars the sum
to be held in trust by my son David until she is twenty one years
of age or until she may be lawfully married.
