Will of John H. Field

Georgia White County

In the name of God. Amen.

I John H. Field of the County of White in the State of Georgia being of sound and disposing mind and memory, although feeble in body, and being desirous to settle my worldly affairs while I have strength to do so, and being especially desirous to make provision for the comfortable support and maintenance of my aged and feeble Grandmother Emily Field who with so much kindness raised me, labored for me, cared for me, and assisted me in making and acquiring the worldly goods which under the blessing of God, I now possess, - do make and publish this my last Will and testament, hereby revoking all Wills by me at any time heretofore made.

And first, I commit my soul to God who gave it and my body to the earth desiring that it may be decently buried, and as to my worldly estate I dispose the same as follows:

First - I desire that all my just debts, including expense of my last sickness and funeral expenses be paid as soon as my Executors herein after named can conveniently do so.

Secondly. I devise and bequeath lot of land Number Fifteen (15) in the First District of Originally Habersham but now White County in said State of Georgia on which I now reside, and on which my house and plantation are situated to my beloved Grandmother Emily Field to be her absolute property and to be held by her & her heirs and assigns forever in fee simple.

Thirdly. I devise all that part of lot of land Number sixteen (16) in the Second district of Originally Habersham but now White County in said State of Georgia which I now own to my Grandmother Emily Field. I have bargained (or conditionally sold) that part of lot number sixteen in the second District of Originally Habersham but now White County which I now own to A J Saxon, and if he complies with his contract and pays the purchase money then I desire and direct my executors herein after named to make and execute for said

part of said lot as baramund to him, and I bequeath
the purchase money to my Grand Mother Emily Field
And if the said A S Saxon should fail to pay for said
part of said lot of land, then I direct my executors
herein after named to retake possession of said land &
I devise the same to Emily Field as aforesaid

Fourthly I devise and bequeath all my personal estate
of whatsoever kind the same may be to my beloved Grand-
Mother Emily Field to be held by her as her own absolute
property

Fifthly I devise and bequeath my whole estate both real
and personal to my beloved Grand mother Emily Field
it being my desire and intention that she shall have
own and propery my entire estate as a means of support
in her declining years; & with my entire estate I give
and bequeath to her my thanks for all her kindness
to me & pray that God may bless her & care for her as
she has cared for me

Sixthly I hereby appoint my beloved Grandmother Emily
Field and my friend Dr John A Moody Executor
& Executor of this my last will and testament

In witness whereof I the said John H Field, to this my
Will, consisting of one sheet of paper, have set my
hand and seal this 21st day of April in the year of our
Lord 1871
