Item the 4th I desire that Jane Bowen daughter
of Rutha Ann Gibson and Maria Turner daughter
+ of the said Rutha Ann share equally
with their Mother Rutha Ann in all that
she may receive from my Estate

Item 5th I will that my Brother Marion W
Smith and my sister Martha E Smith have
during their lives all the Lands that I
own included in the dower of my Mother
at their death then I desire that my sister
Mary M Odell have the said Lands included
in the dower of my Mother

Item 6th I will that my Mother Rebecca Smith
have all my house hold property except my
Beather Bed and my white Counterpane

Item 7th I desire that all the balance
of my property not otherwise disposed of
be sold without appraisement and the
proceeds to be equally divided between
all my Brothers and Sisters including
my Mother

Item 8 I hereby appoint my Brother in law
Levi H Jackson Executor of this my last
will & that he execute the same without the intervention

of any Court whatever as soon as possible after my death &
have here to set my hand & seal & declare this writing to be my last

will in the presence of the following witnesses who see me sign the same
