EXUM PHILLIPS (son of Ethelred Phillips and Sarah Exum), b. June 8, 1757; d. Mar. 1802, in Edgecombe Co., N. C.; mar. 1784, Charlotte Exum (dau. of Ethelred Exum and wife Rachel of Edgecombe Co., N. C.) He was a REV. SOLDIER of N. C., served as Captain of Militia from Edgecombe Co., under Col. Henry Hart; and Col. William Linton. Was at the Battle of Guilford Court House. Drew Pension. (From Pension Record, THOMAS BATEMAN, now living 1835 in Greene Co., Miss., and JACOB HORNE both stated that they had served under Captain Exum Phillips.) (Pension Bureau, Washington, D. C. N. S. D. A. R. 139377.) Children:

JOHN PITTS, JR. (son of John, Sr. and Olive Hardy Pitts), was a REV. SOLDIER of N. C., served as Capt., 1780. He mar., in S. C., Frances Griffin. They moved to S. C., then Ga. He lived in Effingham Co., and was killed 1787 by "Tory Bushwhackers", beaten by light-wood knots and left dead on the Ogeechee River. Children:

BARON DE POCHIETZ of Poland, moved by the spirit of his countrymen, viz: KOSCINSKO, PULASKI and others, came to America and joined the American Army as a REV. SOLDIER. After the War, he bought a large plantation on the Pedee River, S. C. and settled in the lower part of Marlborough. He mar. (name unknown). He d. about 1799. Children:

CHARLES POPE, b. 1748 and lived in Smyrna, Del.; d. in Columbia Co., Ga., Feb. 16, 1803; mar. about 1772, Jane Stokely, b. 1752; d. 1793. He was a Member of the Delaware Society, Order of the Cincinnati before 1800. Buried on his plantation in Columbia Co., Ga. He was a REV. SOLDIER and SAILOR. Was commissioned Capt. in Col. Haslett's Reg. of the Del. State Troops, June 18, 1776. Was wounded at Mamaroneck, N. Y., Oct. 21, 1776. Commissioned Lieut.-Col. in Col. Hall's Del. Reg., Continental Establishment, April 15, 1777; and was in command when Col. Hall was wounded, Nov. 30, 1777. He was also in command of this Regiment when, with the rest of Smallwood's Brigade, they joined General Washington's Army in May, 1778. He led the Regiment in the Battle of Monmouth, July 28, 1778, after the British evacuated Philadelphia, and when Gen. Washington was pursuing them across New Jersey in the direction of New York. He resigned his commission on account of his wounds, Dec., 1779, and was succeeded by Major Joseph Vaughan of Bridgeville. After a brief rest, he took command of the DELAWARE NAVY. Was commissioned Commander of the sloop "Revenge", Aug. 1, 1780; of the schooner "Intrepid", Aug. 27, 1781; and of the "Vigilant", June 10, 1782. Children:

CHARLES POWELL, b. Hertford Co., N. C., Mar. 12, 1758; d. Jan. 30, 1842. A REV. SOLDIER. While residing in Hertford Co., N. C., he enlisted, 1780, serving 3 months under Capt. William Stevens, Co. N. C. Militia. Enlisted 1781, and served 3 months in Capt. James Carter's Co., Col. George Wynn's N. C. Regiment, as Private. Made application for Pension, Aug. 26, 1832, while a resident of Hertford Co., N. C., which was granted.

JAMES POWELL, b. in Brunswick Co., Va., 1733; d. in Glynn Co., Ga., Aug. 1790; mar. in Va., Alse —. (From Land records Brunswick Co., Va.) She d. before 1790. He was a REV. SOLDIER and PATRIOT of N. C. Served in Capt. Martin's Co. against the Cherokee Indians in 1776-1777. This Co. was composed mainly of Orange Co., N. C. and Guilford Co., N. C. Militia. He resided in Orange Co., N. C. during the Revolution. Gen. Griffith Rutherford joined Capt. Martin with troops from Va. and S. C. in July, 1776; this Regiment, under Col. James Martin and Gen. Rutherford, marched into the Cherokee Indian territory. For months they were on this Expedition and it was an embodied corps called out under the authority of the State of North Carolina. James Powell furnished one gun to Capt. James Martin's Co. on this Cherokee Expedition. He served as Private and Lieut. In 1783, Lieut. J. POWELL, REV. SOLDIER, a resident of the State of Ga., applied for bounty land in Ga. He settled in Glynn Co., Ga., with his family.

7. Allen Beverly, b. in Ga., Jan., 1783; d. in McIntosh Co., Ga., Feb. 2, 1844, and is buried at the Powell family grave-yard on the "Ridge" near Darien, Ga. He mar. Mary Calder of McIntosh Co., Ga. (dau. of JOHN CALDER of McIntosh Co., Ga., REV. SOLDIER of S. C. and Ga. and his (1) wife Phoebe Horton. He moved from S. C. after the Rev. War, to Liberty Co., Ga., where he mar. and is buried on the Calder Plantation

"Contentment", now in McIntosh Co. (formerly in Liberty Co., Ga.) Allen Beverly Powell was a Soldier of the War of 1812 and was President of the Senate, from Wayne and McIntosh Counties, Ga. Legislature, when the Treaty with the Indians was signed in 1825 at Indian Springs, Ga.

8. Daughter, perhaps the oldest child, named Winnefred; mar. Mr. House.

JAMES POWELL, reared in Halifax Co., N. C.; mar. in Warren Co., N. C., Oct. 1, 1777, Sarah Myrick, of Warren Co. Marriage bond filed Sept. 29, 1777, signed by James Powell and George Myrick. He was a REV. SOLDIER of N. C., and served as Private 9 months in Capt. Montford's Co., 10th N. C. Regiment; was in the Battle of Brier Creek. Enlisted July 20, 1778. He d. in N. C., Mar. 15, 1817. His widow was allowed Pension on application, Feb. 22, 1841, at which time she was 80 years of age and residing in Halifax Co., N. C. Certificate No. 3604. She d. 1846. Arrears of Pension from Sept. 4, 1845 to Aug. 27, 1846 were paid at the Fayetteville, N. C. Bank on Jan. 4, 1847 to Elijah Fuller as attorney for her son William M. Powell.
NOTE: In a deposition made July 25, 1841, BURWELL DAVIS alleged that he was a REV. SOLDIER and as a comrade served with JAMES POWELL at the "Battle of Briar Creek" on Mar. 3, 1779.

OBEDIAH PRUETT, b. in England, 1752. Came to America and settled in Va., then in Union District, S. C., after the Rev. War. He was a REV. SOLDIER, served as Private in Va. Regiment. A warrant for his services in Militia was issued to him of 2# 4 shillings. (From Auditor's Account Book, Richmond, Va.) (N. S. D. A. R. 106264.) He mar. Molly Palmer.

SAMUEL PRUITT, b. Pittsylvania Co., Va., 1706; made will Nov. 18, 1801, probated Dec. 21, 1801 in Va. He mar. 1754, Lucy Owen. He was a REV. SOLDIER and PATRIOT. Took the Oath of Allegiance and gave of his substance during the War of the Revolution. His name appears in the Pittsylvania Co. "List of Patriots" who furnished supplies during the Rev. War under the Commissioners of Provision. Certificate from Deputy Clerk of Pittsylvania Co., Va. (N. S. D. A. R. 302043.)
