THOMAS, Seth, MA Line, S6209, sol was b in 1754 at Middleborough in Plymouth Co MA & always lived there & he appl there 20 Aug 1832

Seth, RI Line, S24270, appl 8 May 1818 Cayuga Co NY aged 58 yrs 9 mths, in 1820 sol had a wife Caroline & in 1820 he mentioned owing money to one Allen Thomas

Simeon, CT Line, Lucretia, W18131, sol m Miss Lucretia Deshon of New London CT on 19 Feb 1783 at which time sol was of Norwich CT, sol appl 16 Jul 1832 at Norwich CT, sol was b 13 Dec 1753, sol d 2 Jul 1834 & his wid appl 3 Aug 1838 at Norwich CT aged 77, sol's & wid's 3rd child Elizabeth Thomas aged 50 made aff'dt in 1838 at Norwich CT

Stephen, CT Line, Ann, W25479, sol appl 20 Apr 1818 Oneida Co NY aged 80, sol enl at Groton CT & later enl at Middletown (then called Middlesex) CT, in 1820 sol had a wife aged 79, sol had m Ann (---) in 1784 & sol d 7 Feb 1831 in Oneida Co NY, wid appl 2 Jun 1840 in Brown Co WI aged 96, wid stated she had 5 children by her 1st husband but that she & sol had no children, wid's surviving children rec'd final payment on 18 Mar 1844 & were paid to 4 Mar 1841 through the WI Agency

Stephen, NC Line, S289, sol made inquiry 12 Aug 1817 from Palmyra TN, after the Rev sol had lived in Richmond Co NC & in 1796 moved to TN, on 24 Jun 1820 sol was a res of Montgomery Co TN, sol had rec'd a disability pension while living in NC, in 1787 sol was aged 22, sol d 10 May 1825

Thomas, BLW #11758-100-11 Jan 1796 assignee Joshua Ward, srv as a Pvt in the MD Line

Thomas, NJ Line, S22550, sol was b 30 Jan 1761 in Burlington Co NJ & he lived there at enl & he lived there for 2 yrs after the Rev then moved to Cumberland Co PA for 3 yrs then moved to Westmoreland Co PA where he appl 20 Nov 1832

Valentine, BLW #8786-100-10 Aug 1795 assignee James Christie, srv as a Pvt in the NJ Line

Valentinien, NJ Line, Elizabeth, W4084, sol was b 5 May 1753 in Germany & he came to America in 1771 & he m Elizabeth Effit 4 Jan 1786 & sol d 24 Dec 1810 in Salem Co NJ & his wid d 7 Dec 1844 in Summit Co OH leaving children who in 1851 were; Henry Thomas & Catherine Sheets of Cuyahoga Co OH, Elizabeth Bilderback of Northfield OH, Sarah McConner & George Thomas of Columbiana Co OH & they appl 25 Aug 1851, in 1851 one Samuel McConner was a res of Cuyahoga Co OH but no kinship was stated

Willard, MA Line, S33189, appl 8 May 1818 Franklin Co MA, in 1820 sol was aged 65 & sol lived with a daughter the wife of Justin Bishop, R10543, on 6 Nov 1855 an inquiry was made from Marshall KY for the William, no unit of servic given, R10543, on 6 Nov 1855 an inquiry was made from Marshall KY for the wid of dec'd sol William Thomas who it was stated had appl in Brown Co OH but died before receiving his pension, the name of sol's wife was not given

William, BLW #5175-100-25 Mar 1790, srv as a Fifer in the MA Line

William, MA Line, Mary, W19441, sol m Mary Town 7 Jul 1785 both were of Greenwich in Hampshire Co MA, sol appl 9 Apr 1818 at Pittsford in Rutland Co VT aged 60 & in 1830 sol had moved to Brandon VT & he d there 9 Dec 1834, wid appl 11 Oct 1838 at Hubbardton in Rutland Co VT aged 68, wid d 16 Sep 1848 at Brandon VT, in 1820 sol had referred to children at home; Ansel 18, Chester 16 who was living at Hubbardton VT in 1838, Almira Maranda 10, Susan 7 & Horace aged 3 yrs

William, NC Line, S3780, wid was Elizabeth, sol was b 3 Sep 1761 in Rowan Co NC & he lived there until after the Rev lived in Iredell Co NC until 1791 then moved to Sumner Co TN & in 1799 he moved to Wilson Co TN & in 1830 he moved to Dyer Co TN where he appl in 1832 giving his age as 71 on 3 Sep 1832 & sol d 1 Apr 1833 in Dyer Co TN, sol's wid Elizabeth made aff'dt 2 Jul 1834 in Dyer Co TN, sol & wid had m 19 May 1791 in NC, sol had referred to a Henry Thomas as knowing of his service but the Henry Thomas was dec'd in 1834, sol's bro James Thomas aged 78 made aff'dt in 1834 in Dyer Co TN

William, NC Line, S7711, sol was b in 1742 in Queen Annes Co MD & he lived in Anson Co NC at enl, he appl 25 Jan 1833 in Richmond Co NC

William, NC Line, Agnes, W6279, BLW #26102-160-55, sol was b 20 Jan 1763 in Culpeper Co VA & he lived in Guilford Co NC at enl, he appl 3 Sep 1832 Franklin Co GA where he d 27 Nov 1835 & his wid appl there 1 Jul 1839 aged 65, sol & wid had m 19 Jan 1792 & their children were; Elizabeth b 27 Feb 1793 Joel b 23 Oct 1794 & he m Isbel Thomas 2 Oct 1817, Lewis b 8 Dec 1796 & he m Eliza Thomas 8 Nov 1821 Ezekiel b 6 Sep 1798 & he m Sarah Montgomery 29 Jan 1826, William b 23 Oct 1800 & he m Susan C. Burk 28 Jul 1831, Sarah b in Dec 1802 & she m John Rogers 19 Oct 1837, Mary b in Feb 1805 & she m Philip Pruitt 7 Dec 1835, Anna C. b 18 Jul 1808 & she m Henry Mize 25 Jul 1837, Madison H. b 30 or 31 Aug 1810 & he m Nancy K. William, SC Line, wid Aukey, R10517, sol was b in Laurens Dist SC some 2 yrs after Braddock's Defeat (exact date not given), sol m Aukey (---) 25 Oct 1783 in SC, sol moved from SC to Butler Co AL where he appl 13 Aug 1832 & later moved to Lowndes Co AL where he d 13 Jan 1843 or 1845 & his wid d 25 Nov 1846 in Upshaw Co TX leaving children; Philip & William Thomas, Margaret wife of David Rabun, Stact wife of Thomas Hutson, Mary wife of Thomas Peevy, Jane wife of William R. Stringer, John Thomas & Robert Thomas who was b about 1808 & in 1852 lived in Butler Co AL, sol's son James Thomas d in Jun 1833 & he left children of which 3 were living in 1854, towit; Elizabeth wife of James Perdue, Amanda wife of Francis Herlong & Emily wife of Franklin M. Black

William, VA Line, S3782, sol was b in Feb 1754 in Orange Co VA & he lived there at enl & after his service he moved to Fayette Co KY then moved to Henry Co KY then moved to Weakley Co TN in Mar 1831 & he appl there 10 Oct 1832 a res of Dresden TN

William, VA Line, S36827, appl 29 Feb 1820 in Vigo Co IN aged 65

William (colored), VA Line, S38435, appl 21 May 1818 Charles City Co VA aged 63 & he had lived there at enl, in 1821 sol had living with him "a woman" aged 42 or 43 & a girl aged 13, sol d 25 Jul 1824 Winslow, MA Line, Polly, R10512, sol m Polly Gale 23 Nov 1790 both were of Bridgewater MA, sol d 13 Apr 1828 & his wid appl 2 Oct 1838 Plymouth Co MA aged 72 a res of East Bridgewater MA

THOMASON, Byers, VA Line, Sarah, W6281, sol m Sarah White (a John White, Jr. signed (cont next page)
