She further states that the following is as full a description of her said husband as she can give at the time: His enlistment, viz; fair complexion blue eyes & black hair. She further states that she was married to the said John Coney in the County of Laurens State of Georgia A.D. 1815, by one Josiah, a Justice of the Peace in and for said County of Laurens, and that her name before her said marriage was Elizabeth Gay, and that she has

She further states that the following is as full a description of her said husband as she can give at the time of his enlistment, viz; fair complexion blue eyes & black hair. She further states that she was married to the said John Covey in the County of Laurens State of Georgia, A. D. 1818, by one Josiah Horton a Justice of the Peace in and for said County of Laurens, and that her name before her said marriage was Elizabeth Fay, and that she has not remarried since the death of the said John

and she further states that neither herself nor her said husband had been ~~had~~ been previously married to one Sallie Frasier, who died in said County of Laurens some six or seven years previous to the marriage of deponent with the said John Carey, and that her said husband died in Montgomery County in said State of Georgia in the year 1849; and she further declares that the following have been the places of residence of herself and her said husband since the date of his discharge from the Army viz; in Laurens County seven years, in Twiggs County one year, again in Laurens County, about fifteen years, and the remainder of the time since in Montgomery County, all of said Counties being in the State of Georgia. 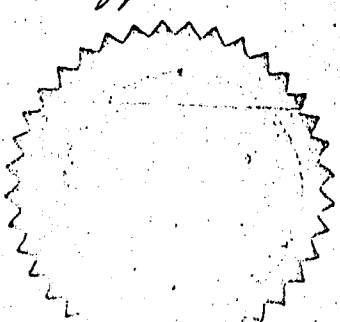
