Lineage. John Green, son of Peter Green of Ainsley Hall, England, emigrated to Providence, Rhode Island onboard the ship *James* on 4/1/1634. In 1644 he returned to London to negotiate for Narraganset. He was associated with the Puritan, Roger Williams of Salem, Massachusetts. The Massachusetts Records indicated that he was fined 100 marks for speaking contemptuously of the magristrates and was fined again 20 pounds and forbidden the jurisdiction on pain of fine and imprisonment. Roger Williams emigrated in 1630 and was driven from Salem in 1635.

Furnifold Green settled in Craven County, North Carolina about 1700. Farnifold and others petitioned Governor Spotswood in 1711 for protection against the Indians but was murdered by the Tuscaroras in 1713.

- Furnifold Green of Craven County, married Holland Applewhite. The Last Will and Testament of Furnifold Green was proven March of 1804 wherein he left his grandson, Allen J. Green, a large tract of land in Craven County. Issue:

Green married Martha Cobb, daughter of General Allen Jones, served as an officer in the Continental Army in North Carolina; was a Surgeon's Mate in 1778, promoted Surgeon in 1779; fought with the Continentals in Charleston in 1780 when he was captured; exchanged 6/14/1781. In 1782 he served as a Surgeon in the First North Carolina Continentals as was mentioned in the "Washington Correspondence. as being one of the officers of the war. (MSS, War Department).

- 2. Major Allen Jones Green, born 2/14/1783, orphaned at the death of his father and raised at *Mt. Gallant* by his grandfather, General Allen Jones. When he was fourteen years of age he was sent to a training ship in Norfolk to be educated for the navy and cruised in the Mediterranean. When it came time for him to marry, his grandfather, General Allen Jones, who had charge of his future bride, said. "You must choose between the navy and a wife." He was married on 10/23/1804 in Halifax to Lucy Pride Jones, the daughter of Major Cadwallader Jones and his wife, Mary Pride Jones of Virginia. Major Green died on 2/6/1832 at *Rose Hill*, near *Landsford*. After his death, his wife removed to Columbia, South Carolina where she died 4/6/1865. Issue.
