Williams of North Carolina

Richard Williams was born 1726 in Monacacy, Maryland and died 5/1781 in New Garden, North Carolina. His father, George Williams, a Welsh Quaker, came to Philadelphia with other Quakers about 1690 and settled in old Prince George County, Maryland (now Frederick County), dying at Monacacy Creek. Richard was one of the Quakers who settled first in Maryland before migrating elsewhere, in this case to the New Garden Meeting in Guilford County, North Carolina about 1752 with their two oldest



children. He gave the land on which the New Garden Meeting House stood, along with adjoining timber tracts. The last battle of the American Revolution was fought nearby and is known as the Battle of Guilford Court House during which time Richard Williams' home was occupied by wounded officers. The officers were sick with smallpox and Williams caught it, dying from it. He was married to Prudence Bales in 1746, a daughter of John Bales (or Beals) of Monacacy, Maryland.
