In the name of God Amen I Jason Meador of the County of Anson in the province of North Carolina being in perfect sense & memory Thanks be to the Almighty God for the same but Calling to mind the Certain-ty of Death & uncertainty knowing that it is appointed that I should Die I give my soul to the almighty God & my body to the Earth from whence it came & ordain this my Last Will & Testament as following to say it is my desire that all my debts to be paid by the Dispositions of my Executors as following. I give & bequeath in premises I give unto my beloved wife Elizabeth the plantation as I now possess and all other my substance During her natural Life & at her Decease it is my Will that the sd. plantation & Tract of land Decend unto my children it is also my will & desire that my said wife Elizabeth keep in possession and enjoy all the rest of my Estate real and personal During her natural Life and at her Decease to be divided as hereafter Directed. I give unto my eldest son Lewis five shillings sterling & also Dora Maria Marion and Thomas one Shilling sterling each. Item it is my Will that at the Decease of my wife Elizabeth that my Plantation and Land and other substance be Equally divided amongst several Children herein named Lewis Jason Job and Mariah to them & their heirs and assigns forever. Lastly I do constitute and appoint my Beloved wife Elizabeth my son Lewis & Job sole Executors of this my Last Will & Testament hereby Revoking Disannulling and making void all former and other wills by me heretofore made ratifying and holding The above premises as Witness my hand seal this Twenty Third Day of March Anno Domini one Thousand seven hundred & Seventy four.
