

Benjamin Debord's Will

The last Will & Testament of Benjamin Debord
of the state of North Carolina Ashe County
I Benjamin Debord Considering the uncertain
ties of this mortal life & being of sound
mind & memory blessed be almighty God
for the same, do make and publish this my
last Will & Testament in manner & form
following. that is to say,

First I give and bequeath unto my eldest
son Jacob Debord, the upper end of my tract
or tracts of land running to a well known
devotional line between him the said
Jacob Debord & Benjamin Debord his brother.

Item I give & bequeath unto my son William Debord
the lower end of my tract or tracts of land
running to a well known devotional line
between him the said William Debord and
Benjamin Debord his Brother.

Item I give and bequeath unto my son Benjamin
Debord the middle part of my land extending
to the well known devotional lines above
named. I also give and bequeath unto my son
Benjamin Debord all my dwelling house
my barn & stables & all other buildings & spring
on the said middle part of my land.

Item I give & bequeath unto my two daughters
Jane, Mary, & Nancy, all my personal property
to be divided equally between them which
said several legacies or sums I will & order
to be paid to the said respective legatees, after
my decease, I further give and devise to my
two sons Jacob William & Benjamin their heirs
and assigns all the land above named situated
lying & being in the state & county aforesaid
to hold to them the said Jacob Debord William
Debord & Benjamin Debord for ever.
And lastly my express will & meaning is

 and I do hereby order and appoint that if
 any differences, dispute, question or controversy
 shall be made aris or happen concerning
 any gift, bequest matter or thing in this my
 will given and bequeathed expressed or con-
 tained that there no suit or suits in law or
 equity or otherwise shall be brought, com-
 ed or prosecuted for and concerning the same
 but the same shall be referred wholly to the
 award order & determination of my friends
 Ruben Debord & Benjamin Debord Jr. both of
 the State of North Carolina & County of Ashe
 & what they shall order direct or determino.
 therein shall be binding & conclusive to all
 & every person & persons therein concerned
 hereby revoking all former wills by me made
 in witness whereof I have hereunto set my
 hand and seal the ninth day of October
 in the year of our lord One thousand eight
 hundred & fifty one.
