11th I give my son William Preston Parsons one dollar

12th I give my daughter Martha Francis Hardy my little spinning wheel

13th I give my son Lewis Briant Parsons my big plow and all my beds and bed clothes

14th All the rest of my ~~property~~ both personal and real of what nature or kind so ever it may be not herein before particularly

disposed of I desire may be equally divided among my three sons to wit

Robert Franklin Parsons, Walter Lerard Parsons & Lewis Briant Parsons which I give to their

heirs forever
