

The Last Will and Testament of James Welch

I, James Welch of the aforesaid County and State being of sound mind but, considering the uncertainty of my earthly existence do make and declare this my last Will and Testament.

First My Executor herein after named shall give my body a decent burial suitable to the wishes of my friends and relations and pay all my just debts together with all my funeral expenses out of the first money that comes into his hands belonging to my Estate.

Second:— I give and devise to my beloved wife Mary Caroline all my Real Estate the lands on which I now reside containing 47½ acres for her natural or as long as she remains my widow.

Fourth:— I give and bequeath to my said beloved wife all my ^{house} household and kitchen furniture two head of Cattle all my hogs all the domestic fowls & Poultry all the Crops on the plantation whereon I now live and all the provisions on hand at the time of my death and all my farming utensils and moneys on hand at the time of my death.

Fifth:— I give and devise to my daughter Amanda Ellen all my real estate the lands on which I now reside containing 49½ acres forty nine acres and one half subject to the life estate of my said wife as devised in a former item of this my last will to have and to hold to her and her children in fee simple forever.

Sixth:— I give and bequeath to my said beloved daughter all my household and kitchen furniture all my Cattle and my hogs all the domestic fowls and poultry all the Crops on the plantation whereon I now live all my farming utensils and moneys and provisions on hand at the time of my death subject to

the life estate of my said wife as devised in a former item of this my will to have and to hold to her and her children forever.

Seventh:— I hereby constitute and appoint my trusty friends to wit:— E. J. Baugus and Moural Dolinger my lawful Executors to all intents and purposes to execute this my last will and Testament according to the true intent and meaning of the same and every part and Clause thereof In Witness Whereof I the said James Welch do hereunto set my hand and seal this 13th day of August 1898
