Geo Blevins, James M. Barker & others, I also bequeath to my said wife Elizabeth Huddler all of our household and kitchen furniture that we may possess at my death to her own use and benefit. I also bequeath to my beloved wife Elizabeth Huddler all the money, notes and accounts if any due to my estate after my death to dispose of as she may think best. Also all cattle and hogs I bequeath and desire that my daughter Belinda C. who first married as I understand a man by the name of Simback & the heirs of my two sons Dec. James Madison Huddler and John P. Huddler one certain Town Lot in the Town of Jefferson Ashe County N.C. known as lot No. 100 Town plat. it being the lot where the Martin Shalley now lives as the deed will show one half acre more or less for the said heirs above named to have the said lot forever to be equally divided between the said heirs Belinda I M & J. equally into three parts. I hereby appoint my beloved wife Elizabeth Huddler my executrix to this my last will and Testament to execute the same to the full intent and meaning thereof and I hereby revoke all other wills and Testaments heretofore by me made, In testimony whereof I have hereunto set my hand and affixed my seal this the 25th day of November 1892.
