

Last Will & Testament of Nancy C. Lewis

In the name of God Amen, I Nancy C. Lewis of the County of Ashe and State of North Carolina being of sound mind and memory and considering the uncertainty of this frail and transitory life, do therefore make and ordain publish and declare this to be my Last Will and Testament; That is to say, First after all my lawful debts are paid and discharged, I bequeath, give and dispose of the residue of my personal property as follows; to wit;

To my grand child, Corn A. Gore the worth of a colt and heifer, the colt worth twenty five dollars the heifer worth fifteen dollars, making forty dollars to but against and be equal to a colt and heifer which I gave to my son Harvey Lewis several years ago. Second I give and bequeath to Corn A. Gore my Grand child my sewing machine press and side saddle worth fifty dollars. Third I give and bequeath to my son Harvey Lewis my all Iron ware to but against and be equal to the sewing machine press and side saddle worth fifty dollars.

Fourth I give to my said Grand child the three bedsteads now in the house, three feather beds, three under bed ticks, nine blankets, four sheets, four covers, two patch, counterpane five quilts, back set, tea kettle one and a half gallon kettle and a small table and eight pillows all worth seventy four dollars to but against and be equal to one bedstead. Five feathers beds, three under bed ticks, nine blankets, six pillows, three covers, two quilts and sheet, Spoon, Rifle gun, big spinning wheel, Count Kuhl, Eight juce, Clock and turn Flour all of which I give and bequeath to my son Harvey Lewis all worth seventy four dollars. Which bequest I have now made as near equal as possible, and I am now due to my son Harvey Lewis eighty dollars to be paid of the residue of real estate or personal property, not bequeathed, to be equally divided after my decease, between my son Harvey Lewis and my said Grand child, Corn

A. Gore, that is after all my lawful debts are discharged as above stated, Like wise I make constitute and appoint Thomas J. Farmer of Solitude North Fork Town Ship, in the County North Carolina Executor of this my last Will and Testament. Herby revoking all former Wills if any by me made. In witness whereof I have hereunto subscribed my name and affixed my seal the 9th day of Feb A.D. 1892.
