The undersigned witness thence, who being duly sworn doth depose and say and each for himself depose and say that he is a subscribing witness to the paper writing now shown him purporting to be the last will and testament of Thomas S. Caloway that the said Thomas S. Caloway in the presence of this deponent subscribed his name at the end of said paper writing which is now shown as aforesaid and which bears date of the 1<sup>st</sup> day of January 1854. And the deponent further saith that the said Thomas S. Caloway the testator aforesaid at the time of subscribing his name as aforesaid declare the said paper writing to be his last will and testament and this deponent did thereupon subscribe his name at the end of said will as an attesting witness thence and in the presence and at the request of the said testator. And this deponent further saith that at the said time when the said testator subscribed his name to the said last will as aforesaid. and at the time of deponent subscribing his name as an attesting witness thence as aforesaid the said Thomas S. Caloway was of sound mind and memory of full age to execute a will and was not under restraint to the knowledge information or belief of this deponent. And further these deponents saith not truly sworn and subscribed before me 30<sup>th</sup> Sept. 1857

I Thomas S. Caloway of Abe County and State of North Carolina considered to be of proper and sound mind and proper consideration knowing the uncertainty of my mortal existence do this day make and constitute the following my last final will and testament to wit.

- 1<sup>st</sup> I will that all my just debts be paid
- 2<sup>nd</sup> I give unto my beloved wife Pertina Elizabeth Caloway all of my home plantation wherunto I now live during her mortal life
- 3<sup>rd</sup> I give to my wife Pertina E. Caloway all of my personal property consisting of all my live stock with my Blacksmith and farming tools my household and kitchen furniture and all of my books for ever for her own use and benefit
- 4<sup>th</sup> I will that my old homestead after the death of my wife P. E. Caloway shall be sold at public sale to the highest bidder. no one entitled to bid but those interested and the proceeds equidly divided between all of my sisters or their children.
- 5<sup>th</sup> I give unto my grand nephew Wiam C. Jones my one half interest in a fifty acre tract of land adjoining Bledsoe. Hender Herb's. & others. further I give to my dear wife Pertina all of my lands consisting of a part of two or three tracts lying on the Painful Branch to be hers absolutely for her own use and benefit  
Further I appoint Norman Jones Executor to carry out all meaning and intents of this will
