We have viewed and appraised the homestead of the said W. H. Hauck and the dwellings and buildings thereon, owned and occupied by W. H. Hauck as a homestead and valued at the sum of same at \$500.00; and the tract bounded as follows:

Beginning on stake on north side of Bluff Mountain, the old Pathway Corner, running south 67 west 290 poles to a mahogany on dividing ridge; then south 67 west 290 poles to a mahogany on dividing ridge; then south 30 east 240 poles to corner face of ridge on top of mountain; then with the top of Bluff Mountain east 80 poles to water oak, north 66 east 10 poles, north 69 east 10 poles, north 49 east 8 poles, north 54 east 14 poles, north 69 east 9 poles, south 85 east 12 poles, south 49 east 8 poles, south 75 east 11 poles, south 82 east 14 poles, south 83 east 25 poles, south 67 east 15 poles, then north 40 east 36 poles to a stake in line from the mahogany, north 10 west 11 1/2 poles; then north 18 east 95 poles to the beginning, containing 87 acres.
