

William Baker Last Will and Testament

State of North Carolina
 Ashe County Jan^y 18th 1870

I William Baker of
 Said county being of Sound mind and memory
 thank be to God Do make and publish this my
 Last will and testament as follows
 First I give to my beloved wife Elizabeth Baker
 one hundred acres of land at my old place where
 I married from the said to include the Dwelling
 house and all the buildings thereon During her
 natural life time or widowhood and no longer
 I also bequeath and give her mare and five cows
 and ten head of Cattle and seven and pigs and
 four birds and furniture belonging to them and
 Chair of my table with the cloths paper and
 bureau also one big plow and one shovel plough
 three mending haws two pair of Scouring two Syles
 and cradles two mattresses and two guns for Hyrum
 and Franklin As I have given my son Chedraet
 one hundred acres of land that is value at four
 hundred Dollars and one have least that is value at
 one hundred dollars I also give unto my son
 Hyrum one hundred acres of land fifty acres where
 I now live and the other fifty on the south
 side of The Kelly tract
 I also give to my son Franklin one hundred
 acres of land that I have willed to my wife
 at her Death or during her widowhood I
 have give my Daughter Mary thirty five
 Dollars also to my Daughter Rely thirty five
 Dollars also to my Daughter is to have thirty
 five dollars to make her Equal to the others also
 to my Daughter Sarah I give thirty five
 Dollars to make her Equal to the others
 also to my Daughter Cynthia I give thirty five
 Dollars to make her Equal with the others

also to my Daughter Nancy & give thereby fifty
Dollars then so one cow not named in my will
that I give to Lary & also give to Dely Edminsons
wife and my Daughter Nancy Harby Seven acres
of land lying on the north fork known as Big Place
the two mules that I own is to be kept on the farm
and plowed in the lands of my wife but not to
be disposed of & also have one Yoke of cattle that is
to be kept on the farm and not to be disposed of
I also leave in the hands of my wife all the cooking
Pots and table ware all the other property not
named in this will is to be sold and after my
Just Debts are paid to be equily divided with all my
heirs I also appoint and constitute my friend
Jesse B. McMillon Executor to this will and William
B. Rines is also requested as my executor this will is
also appoint them as Guardians for my minor children
