The Last Will and Testament of John Hagaman

I John Hagaman do Will and bequeath my land property in said County and State as follows first I bequeath to my sons Hugh Hagaman, Thos. J. Hagaman and Francis B. Hagaman my entire tract of Land lying in said County in Laurel Township and containing one hundred and fifty acres, adjoin Tompou Eggers and Lane and known as the David Price property said Land to be divided between the three Boys as follows Hugh to have all that part about the Road adjoining Tompou which has been run off and also two acres at the upper end of the Meadow; all to contain forty five acres The Balance to be divided between Thomas and Francis as follows. Thomas to have fifty acres on west end of the remaining part beginning on the west end near John Cusbourne's Corner and running East direct on to a Branch in the field then to Stewart's Line or as to include fifty acres, and Francis is to have the Home place including the improvements, said Lands to be Estimated at twelve Hundred Dollars or four Hundred Dollars per share. It is under stood that my wife Eliza Hagaman and my self are to hold a life time Estate on the Home back and said tract of Land goes with the Home of my son Francis Hagaman at our death It is further under stood that my two Daughters Eve and Alice that they are to have their support on the said premises as long as they remain unmarried I will and bequeath to my two Daughters be equal in all my Estate with the Boys and should there not be enough property or personal effects then the Boys are to pay them enough to make their parts four Hundred Dollars each My sons Daniel & Alexander having here before received their share of my Estate it is under stood that they are to assist in paying with Hugh Thos. & Francis that part that will be due the girls in order that all may be equal in my estate I do here by appoint Isaac Dougherty to execute this will and make all the necessary settlements in the division of the same
