be Equally Divided amongst my four Nephews that is Frederick
Becton George Becton Edmond Becton & Michael Becton.

I likewise constitute & ordain my Beloved Wife Executrix & my trusty
friends Frederick Becton & George Becton Executors of this my Last
Will & Testament & I do hereby utterly disallow Revoke all &
Every other former Testament Wills Legacies & Bequeaths and
Executors by me made Ratifying & Confirming this & no other to
Be my Last Will & Testament.

Thanks be to almighty God for it and knowing that it is appointed
for all Men to Die to God I Bequeve my Soul and my body to the
Earth to be buried at the Discretion of my Executors hereafter men-
tioned and as for what worldly goods it hath pleased Almighty
God to bestow upon me I give and Dispose of in manner and form
as followeth. Ist I give and bequeve unto my beloved Brother John
Herinton the Plantation that I now live on and all the Land Be-
longing to it and my horse Brid and Saddle. It I give and beque-
veth unto my Loving Brother Charles Herinton a pease of Land kno-
wn known by the name of prices " " " " and my Shooting gun
as for the rest of my worldly Estate I leave to be Equally Divided
between my Loving Mother & my Brother John and Charles & my Sister
Elisabeth and my Sister Hannah and my Sister Mary to be Divi-
ed when my Brother Charles comes of Age of won and twenty years
my Will and Desire is that my Mother shall have the use and oc-
cupation of the above mentioned Plantation during her Natural life
Lastly I appoint my trusty friends James Bond and Richard
Flammakin my sole Executors of this my Last Will and Testament
