it me and my body to go earth to be buried all
the descretion of my children hereafter, my worldly
goods followeth after I gave to my daughter Margaret
five shillings I gave to my son Edward five shillings
I gave to my son Dennis five shillings, I gave to
my daughter Sarah five shillings, I gave to my
son Henry five shillings, I gave to my daughter
Jen five shillings, I gave to my daughter Mary five
shillings, I gave to my daughter Alex five shillings. I
gave to my son John a cow. I gave to my son David
my land and plantation to him and his heirs
forever that is "County and a
barrel of feathers and a gun and a saw and six
shats, I give to my daughter Ruth two cows, heads and
my eland and trunk, I give to my son William
twelve head of cattle and a feather head and two
iron pots and pot rack and the tools and three
desks and a basin and six and twenty head
of hogs and a chest and table, a frying pan
a saw, and a wooling wheel" and cards
and a dozen of spurs and a corn I appoint
my son David to be my sole executor to see
this my last will and testament fulfilled.

tality of my body and knowing that it is appointed
for all men once to die, do make and ordain this
my last will and testament, that is to say prin-
cipally and first of all I give and recommend my
soul into the hands of God that gave it and for my
body and for my body I recommend it to the earth
to be buried in a Christian like and decent manner
at the descretion of my Executors nothing doubting but
that the General Resurrection I shall receive the same
again by the mighty power of God and as touching
such worldly estate wherewith it hath pleased God
to bless me in this life I give bequeath and dispose
of the same in the following manner and form.
Inprimis, I give and bequeath to Ann my dearly
beloved wife Ann Lewis whom I likewise constitute
make and ordain my only and sole executor of
this my last will and testament all my lands
and tenements by her freely to be possessed and
enjoyed and I do hereby utterly disallow revoke and
disannul all and every other former testaments wills
and legacies, bequests and executors by me in any way
before this time named, willed, and bequeathed
ratifying and confirming this and no other to
be my last will and testament.
