Item I Devise all my Real Estate yet or disposed of to my well beloved Wife Gemina and my Children Isaac Samuel and Nancy to be equally Divided

Item I bequeath my Silver Watch to my well beloved father in Law Samuel Boutwell

Item I bequeath all the Remainder of my personal Estate to my well beloved Wife Gemina and my Children Isaac Samuel and Nancy and I do hereby constitute ordain and appoint my well beloved father In Law Samuel Boutwell and my well beloved Son Isaac Chauncy Sole Executors to this my last Will and Testament and I do hereby Revoke and lay void all former Wills and Testaments by me made fully confirming publishing and Declaring this my last Will and Testament In witness whereof I have hereunto set my Hand and fixed my seal this 28 of December
